Course Description

VETT 341 Veterinary Clinical Pathology Lab

Hands-on laboratory course regarding the study of hematology, urine analysis, cytology and serum chemistry principles and procedures commonly utilized in veterinary medicine. This is the laboratory component of VETT 340 and must be taken in conjunction with it.

Student Learning Outcomes (Should be measurable; observable; use action verbs)

1. Students will demonstrate the ability to perform a variety of clinical pathology procedures to include those related to blood, urine, feces, and tissue.
2. Students will effectively be able to identify common findings in microscopic evaluation of blood, urine, feces, and tissue.
3. Student will be able to properly collect, process and ship specimens to a referral laboratory for analysis.
4. Demonstrate the understanding of how to prepare, handle and submit appropriate samples for diagnostic analysis in order to ensure accuracy of results.
5. Students will learn their role as a veterinary technician, team member, and client educator in a laboratory, clinical, and diagnostic setting.
