Course Description

This course covers the major aspects of real estate investment. Commercial properties will be emphasized. The course begins with an overview of the fundamentals of income producing real estate and builds on these concepts as we consider the forces that influence the cyclical, fragmented, and inherently local business of real estate investment. The course will expose students to current “real world” real estate finance and investment situations.

Course Learning Outcomes

At the conclusion of the course the students will be able to apply appropriate analytical tools to reach at prudent real estate decisions related to real estate investments.

1. Apply appropriate analytical tools to reach at prudent real estate decisions related to real estate investment.
2. Create educated opinions on real estate asset values.
3. Explain and critique various real estate entities and their activities in the asset financing system.
4. Develop appropriate skills to apply technology (spread sheets) for real estate financing and investment analysis
5. Conduct real estate market analysis study and estimate asset values.

Course Learning Outcomes 2 and 3 address COB Student Learning Objective 3: Students will identify and evaluate ethical business issues.
