COURSE DESCRIPTION

This course focuses on the administration and management process and procedures used in operating the components of the criminal justice system (i.e., police, courts, and corrections). The structural foundation of these subsystems is analyzed using theoretical and research information. In this course, students become familiar and experienced in performing critical evaluations of organizations' operations, analyzing, and investigating policy-making processes. Adopting techniques that allow them to consider implementing new policies and to perform policy assessment.

Student Learning Outcomes

- 1. Identify fundamental processes used in the operation of the criminal justice subsystem.
- 2. Develop skills which will allow them to critically evaluate managing styles used in each component of the criminal justice system.
- 3. Able to write and discuss sharing gained information that describes management styles employed in various criminal justice organizations.
- 4. Demonstrate their familiarity with organizational issues and offer researched solutions and innovative policies.

COURSE REQUIREMENTS

ASSESSMENTS

Introductory Reflection

Students will submit a 300–500-word personal reflection introducing themselves, their professional background, and their goals for the course. This reflection should also include preliminary thoughts on leadership in justice administration and any areas of the criminal justice system they are especially interested in improving or learning more about. This assignment is worth 6% of the total grade.

Capstone Project

Students will complete a final project that demonstrates synthesis of course concepts, research skills, and professional application. Projects should be 8-10 pages in length (not including the title page or references) and include at least five scholarly sources. Students may choose from the following format:

- 1. Strategic plan for reforming a justice agency
- 2. Research-based policy proposal for an emerging issue
- 3. Agency-wide implementation plan for new technology or procedures
- 4. Leadership development program design for a justice agency

Regardless of the format, students must include a clear problem statement, goals, analysis, and recommendations in a professional and organized manner. This assignment is worth 30% of the total grade.

Policy/Management Memos

Students will write concise 1-page memos addressing practical administrative or policy challenges related to weekly topics. These memos can be written for either a real or hypothetical agency head or stakeholder, using clear, professional language. Memos will be evaluated on clarity, relevance, and the ability to apply course concepts to real-world decision-making. This assignment is worth 18% of the total grade.

Strategic Leader Presentations

Students will create a series of short (3-5 minute) recorded presentations addressing a leadership challenge prompt. Each presentation corresponds with a major sector of the criminal justice system: policing (Week 2), courts (Week 4), and corrections (Week 6) for a total of 3 presentations. Presentations should demonstrate strategic thinking and use a combination of course materials and outside research to successfully address the prompt. Visual aids such as slides are encouraged but not required. This assignment is worth 18% of the total grade.

Weekly Discussion Posts

Each week, students will participate in discussion forums to engage with course materials and their peers. Initial posts should respond to the weekly prompt and incorporate readings and research. These posts should be between 300-400 words in length and follow APA norms. In addition, students must also include a question to stimulate further discussion for their peers within the original post. Lastly, students must respond to at least two classmates' questions. These responses should be between 150-250 words, substantive, and address the question posed by the original poster. This assignment is worth 28% of the total grade.
