## Course Description

This course will provide students with the fundamentals of conducting and evaluating research in criminal justice. Topics include defining research problems, ethics in criminal justice research, selecting and measuring variables, stating hypotheses, sampling, and developing experimental research design.

## Student Learning Outcomes

1. Demonstrate an introspective, criminological perspective on research methods in the social sciences
2. Identify qualitative, quantitative, and mixed social science research methods
3. Critically analyze peer-reviewed research in criminal justice
4. Illustrate writing skills that communicate complex ideas succinctly

## Assessments

\*\*\*Please check your ETAMU email account and D2L daily because important information about this class could be emailed or uploaded to you. A breakdown of course requirements and how each will contribute to your course grade is included below. *Assignments and exams may be made up without penalty if they are missed due to an excused absence.*

### Research Project (40%)

Students will begin designing and developing their own research project, with topics commensurate with their own interests. The project includes four (4) component parts:

RP1: Development of research topic (5%)

RP2: Development of research questions (5%)

RP3: Annotated Bibliography (10%)

RP4: Literature Review (30%)

\*\*\*Each of these components are scaffolded and built into each other. **Students must turn them in sequentially.** Students will **not** be allowed to “go back” and finish incomplete components after another section is due.

### Research Case Study (10%)

Students will be presented with a peer-reviewed published paper related to criminal justice. After reading it, students will write a 2-page reflective essay, pointing out potential issues with research design, methodology, research ethics, or other salient issues discussed in class.

All course writing assignments will be submitted online through D2L and utilize TurnItIn plagiarism software. Papers should be in Times New Roman, size 11 font, one- inch margins and double-spaced. Late assignments will be accepted but will be deducted 10 points for each day (or part of the day) they are late (without approved documentation).

**Midterm Exam (20%):** One online exam will be administered (D2L) in this course. The midterm will be graded on a 100-point scale and include approximately 40 multiple-choice and true/false questions. The exam will cover the assigned readings, uploaded lecture videos, and assigned multimedia. Students will need access to reliable internet services and a quiet work environment conducive to test taking. **The exam and access password will be made available online on the D2L system on September 24th at 10AM and close at 11:59PM on September 28th. Once a student is ready and opens the exam, they will have one hour (60 minutes) to complete all the questions. Students will not be able to go back to it throughout the day!** More detailed information on the procedure for taking online tests can be found on D2L under ONLINE EXAMS in the CONTENT folder.

**Course Journals (20%, 2 entries worth 10% each):** On scheduled weeks, a journal prompt will become available under the Assignments folder in D2L. Students will have until the following Sunday at 11:59PM to write a 400–500-word response, which should incorporate both class concepts and personal experiences. Extra emphasis will be put on introspective and well-developed ideas. Each

prompt will correspond with that week's content area (e.g., child abuse or theories of victimization) and should be completed *after* viewing the week's lecture video and/or textbook reading.

**Makeup Exam Policy:** I totally understand that life happens. Students that experience exceptional circumstances which cause them to miss a scheduled exam should contact me ASAP. Students that have a university approved absence or otherwise produce written documentation regarding their absence will be scheduled for a make-up time. Students that have not reported their absence or spoken to me within 2 days of the exam will be considered unexcused and receive a "0" score for that exam.

## Classroom Guidelines

**Electronic Device Policy:** Please refrain from the use of electronic devices during class, as it is distracting to not only you, but also to your instructor and peers. Laptops should only be used for note taking unless they are part of the instructor assignment and discussion for the class day.

**Classroom Civility, Respect and Tolerance:** University study is largely about exposure to a diverse range of worldviews and lived experiences. **This course relies on challenging and critiquing deeply held societal beliefs over a wide range of sensitive topics.** Students should engage in discourse with other students and the instructor respectfully. **My classroom is predicated on principles of mutual respect** and students are expected to exhibit this same respect for the diversity of ideas. **Forms of incivility towards other students or the instructor will not be tolerated.**

**Instructor Error:** Because instructor errors can and do occur, students should keep an extra copy of any work they submit. In addition, make sure to keep and safeguard graded assignments and tests until final course grades have been posted.

## Course Policies

**Access to Grades:** All grades will be available in D2L. Please note that I am unable to furnish any information about grades or student status via e-mail or telephone. This is considered a violation of the Family Educational Rights and Privacy Act of 1974 (FERPA), even with student permission or at student request. Verify your D2L grades often. Discuss grade posting errors/omissions with me immediately.

**Borderline Grades:** Students will not be awarded extra points at the discretion of the instructor. Be aware at the outset that this course has a firm policy against grade "bumping". However, students will be automatically rounded to a higher letter grade at the .5 threshold (i.e., 89.5% is an A).

**Incompletes:** Grades of "incomplete" are given only under rare circumstances when students provide detailed documentation of a significant crisis (e.g., serious illness of the student or death in the immediate family) near the end of the semester and which render them unable to finish the course. Incomplete grades will not be given under any other circumstances. Students with circumstances
