**Course Information**

**Required Text: *No Textbook required. Lecture notes provided by the Professor. Students can use any Intermediate Microeconomics Textbook available in the library.***

Prerequisites: Lvl U ECO 232 Min Grade C or Lvl U ECO 2302 Min Grade C

**Course Basics:**

Economics 332 is an intermediate level Microeconomics which assumes knowledge of High school algebra. The course is designed as an overview of the essential elements of Microeconomics as an intellectual, decision-making discipline. Economics is normally treated as two distinct, though interrelated, broad sub-disciplines: Microeconomics and Macroeconomics. At the decision-making level, however, those dividing lines tend to be blurred. This course will focus on both pure theory (theory for the sake of understanding the concepts and principles) and theory as an aid to economic decision-making under scarcity of resources relative to human wants at the individual household or firm level.

**Instructional Methods:** The professor will provide topical lecture notes and videos (if available) through D2L Brightspace Content and/or emails. Questions can be asked through email ([kishor.guru-gharana@tamuc.edu](mailto:kishor.guru-gharana@tamuc.edu)) 24/7 throughout the semester.

**Student Responsibilities/Tips for Success in the Course**

1. Students are expected to:
  - a. Read Lecture notes provided by the Professor.

4. Homework problems are assigned and graded about every three to four weeks. Two lectures are covered in each assignment except the first assignment with three lectures. Solutions to Assignment problems will be provided after the grading.
