Course Description

The class presents an in-depth examination of the issues related to corporate governance in an ethical society. General theories of governance provide a foundation for an examination of the role governance decisions play in promoting the long-run sustainability of the community in which the firm operates. Global comparative analysis will help identify best practices in internal and external governance mechanisms.

- 5. Demonstrate an understanding the importance of sustainability in today's business world

MEANS OF ASSESSMENT

Module Quizzes: Timed module quizzes occur weekly. Module quizzes may contain multiple-choice and true/false questions; each quiz is worth 30 points. These quizzes assess student knowledge regarding module readings, audio lectures, and required videos. **Outside assistance of any kind and copying/sharing questions in any format are strictly prohibited and will be considered a violation of the TAMUC Code, and copyright law.** See the Class Schedule for quiz dates.

Discussion Questions: Students are required to complete two discussion questions for each module (up to 30 pts. each). The initial discussion question responses will be due on Thursday of each week. The two responses are due by Sunday night. Then, every student will be required to post two follow-up statements/questions to other students' initial postings. The follow-up statements/questions can be to the same student or two different students.

Each initial posting is to be a minimum of 300 words and follow-up postings is to be a minimum of 200 words. Please include the properly APA formatted citations for any sources utilized for your discussion questions.

Rubric for Discussion Questions:

- Initial Posting – Up to a Maximum of 20 Points
- Follow-Up Postings – Up to a Maximum of 5 points each (Max. of 2 receive credit.)

Extra Credit: Extra credit **may** be posted throughout the course to assist students in learning the presented material and to assist them in preparing for the weekly quiz. The extra credit is completely voluntary and will not count against the student if not taken. Students must complete the weekly discussion questions before they will be granted access to the extra credit. **ALL students must complete all coursework, including the discussion questions and weekly quiz, to retain the extra credit earned during the course.**

APA Paper: Students will be required to submit fifteen (15) 5-page papers with a Title page, a references page, and a minimum of 3 narrative pages (APA

format, 12 point font, single-spaces, with a references page) in discussing a relevant topic for the week's discussions. The students choose the topic. The paper is to be submitted in a MS Word format and is due Sunday nights at 11:59 p.m.
