### Course Information

As organizations expand, managing supply chains becomes increasingly complex, requiring accurate forecasting, effective inventory control, cost reduction, and agility in meeting customer demands. This course introduces mathematical optimization modeling and value-stream analysis as key tools for designing and managing supply chain networks. By applying these approaches, participants will learn how to create efficient, resilient, and responsive supply chains that effectively serve both internal and external stakeholders.

- Recognize emerging concepts in Value Stream Mapping and Supply Chain Management Network Design, relevant to supply chain management including closed loop supply chain management, Inventory Management, Supply Chain Risk Management, to include logistics network planning, centralized and decentralized distribution strategies and supply chain management product design. - How to design, measure and incentivize the supply chain network/supply base including financial impacts of strategic alliances in a supply chain/supply base, lifecycle assessment as well as managing and monitoring the supply chain/supply base. (SLO: 2, 3, 4, 5)
