# **Course Description**

This course offers lecture, laboratory, and online interaction to provide a foundation in data management concepts and database systems. It includes representing information with the relational database model, manipulating data with an interactive query language (SQL) and database programming, database development including internet applications, and database security, integrity and privacy issues.

- 1. Install, configure, and interact with a relational database management system.
- 2. Describe, define and apply the major components of the relational database model to database design.

- 4. Utilize a database modeling technique for a single entity class, a one-to-one (1:1) relationship between entity classes, a one-to-many (1:M) relationship between entity classes, a many-to-many (M:M) relationship between entity classes, and recursive relationships.
- 5. Define, develop and process single entity, 1:1, 1:M, and M:M database table.
- Comprehend then implement web database programming fundamentals by developing an application program interface (API) to access and maintain a relational database.
- 7. Learn and implement the principles and concepts of information integrity, security and confidentiality.
- 8. Apply ethical computing concepts and practices to database design and implementation.
