Course Description

SED 400: Students will synthesize and validate concepts encountered during clinical teaching. Regular seminar sessions will focus on the situations, questions, and concerns that arise directly from the clinical teachers' experiences in secondary public school classrooms. Prerequisites: SED 300, SED 330, SED 331, SED 332

SED 401: An experiential component in which clinical teachers design and implement curriculum and model the use of a variety of classroom assessment techniques. The clinical teachers will use cutting edge technologies for both creating and assessing lessons. Field based experience required.

Student Learning Outcomes

1. **Synthesize and apply theoretical knowledge in authentic classroom contexts:** Students will demonstrate the ability to connect educational theory with real-world practice by analyzing classroom situations, validating pedagogical concepts through direct experience, and articulating how research-based strategies translate into effective teaching practices in secondary public school settings.
2. **Reflect critically on clinical teaching experiences:** Students will engage in ongoing reflective practice by identifying and analyzing situations, questions, and concerns that arise during their clinical placement, participating meaningfully in seminar discussions, and developing solutions to classroom challenges through collaborative problem-solving.
3. **Design and implement standards-based curriculum:** Students will create lesson plans and instructional units that align with content standards and student needs, implement these materials in their clinical placement, and demonstrate effective instructional delivery techniques appropriate for diverse secondary learners.
4. **Integrate technology-enhanced assessment and instruction:** Students will utilize current educational technologies to create engaging learning experiences and implement various formative and summative assessment techniques, demonstrating proficiency in both digital content creation and technology-supported evaluation methods.

General Overview of Required Work

Instructional Methods

Our clinical teaching courses employ a field-based experiential learning model that immerses undergraduate students in authentic educational environments. Primary learning occurs through sustained field experiences where students engage directly with classroom practices, supported by structured reflection prompts that encourage critical analysis of their observations and interactions.

Eight strategic seminars throughout the semester focus on essential teaching themes:

classroom management, relationship building, working with diverse learners, accommodations and differentiation, data collection, and professional ethics. These seminars utilize research-based presentations, interactive activities, and collaborative exercises that connect theoretical knowledge to practical application.

This blended approach ensures students develop both practical competencies through direct classroom exposure and theoretical understanding through evidence-based content. Prompted reflections bridge field experiences with seminar learning, helping students synthesize observations with research-based practices while developing their professional teaching identity and maintaining high standards of ethics and professionalism.

A Note on Learning: As we pursue learning together, I strive to keep the following guiding principles (inspired by the Chronicle of Higher Education):

- **Put people first.** As we learn human-centered philosophies and methodologies in this course, I hope we practice empathy and be cognizant of how our own realities (day-to-day lives) can be imposed upon others whose lives may differ drastically from ours.
- **Stay informed.** We will keep ourselves educated about any public health and safety situations and make informed decisions about our personal, social, and professional lives.
- **Communicate early and often.** Even when we are physically and socially apart, we can remain connected through various communication platforms. Always reach out if you need anything necessary to support your learning and your own well-being. The syllabus and schedule are subject to change.

Syllabus Change Policy

The syllabus is a guide. Circumstances and events, such as student progress, may make it necessary for the instructor to modify the syllabus during the semester. Any changes made to the syllabus will be announced in advance.

Grievances
