Course Description

This course is designed to introduce students to the science of major natural disasters, exploring their causes, impacts, and mitigation strategies. Emphasis will be placed on understanding the mechanisms of why natural disasters occur and the environmental, economic and societal implications of disasters.

Instructional Method: The course is blended. we will meet in the classroom on Thursday and It will be online on Tuesday for assignment, video, project or quiz.

The syllabus/schedule are subject to change.

Student Learning Outcomes

- 1. Critical Thinking:** Students will be able to differentiate between fact and opinion; be able to discern between relevant and irrelevant information, recognize bias in source material, and critically examine a diversity of source material. Students will be able to describe the physical mechanisms that combine to form both normal and extreme weather patterns. Students will also be able to distinguish which energy sources (internal and/or external energy) are fueling which natural disasters. Explain how tectonic plate dynamics result in earthquakes, volcanoes, and other geologic natural disasters. Students will be able to describe the factors that contribute to other types of disasters either natural or human-made disasters. Describe the factors that tend to increase or decrease the severity of natural disasters, and what the effects of natural disasters are on human populations worldwide. Students will also be able to describe the prediction phenomena, warning systems, and precautionary measures for individual natural disaster.
- 2. Communication:** In written, oral, and/or visual communication, students will communicate in a manner appropriate to audience and occasion, with an evident message and organizational structure. The course is designed to present one natural disaster by a group of students at the end of the semester where students will answer the listed predetermined questions for their preselected disaster. Class presentation will help students to exchange their research findings on a specific disaster to the whole class.
- 3. Teamwork:** Students will be able to work together toward a shared purpose relevant to the course or discipline with a sense of shared responsibility for meeting that purpose. Students must do their group study to develop a report for their preselected disaster. Students will learn how to work in a group, how to distribute workload among group members, and finally how to solve problems in a group. There will be equal group members for each group. In class, groups will work for 10 to 15 minutes to answer 1 or 2 questions. This way instructor will also be able to evaluate the teamwork performance for each group other than the quality of report and class presentations.
- 4. Empirical and Quantitative Skills:** Students will be able understand and utilize mathematical functions and empirical principles and processes. There are calculations on how to measure the Adiabatic Lapse rate, atmospheric temperature and pressure gradient, how to calculate the flood intensity by measuring stream cross sectional areas.

COURSE REQUIREMENTS

Minimal Technical Skills Needed

Students should have Algebra, basic math, basic chemistry skills.

Students should be able to navigate the D2L for assignments, quizzes and resources.

Students should be able to use basic word processing and presentation software, interpret charts, graphs and maps.

Students should be able to search for credible scientific and governmental disaster information online.

Instructional Methods

Conducting lectures, resorting to videos and visual-aid presentations, e.g., "PowerPoint" and "You tube", solving math problems together with the students in the classroom, expecting student participation in the classroom discussions, assigning Exams and homework assignments, etc.

Student Responsibilities or Tips for Success in the Course

Turn-in all the assigned academic work; actively participate in verbal discussions; take notes and copy-write explanations during class periods; take assigned written Exams; log into the course website, regularly; complete the assigned weekly study.

One Assignment (10%)

1. Consider one Natural Disaster.
2. Why are you interested in that Disaster? Example: explain about their local or regional or worldwide activities.
3. Consider one specific geographic location of that hazard.
4. Methods to predict that hazard (if any).
5. Explain How did that hazard started to form at that location:
 - a. Factors Influencing that hazard to take place
6. Risk Assessment of that specific hazard
 - a. Human Fatalities
 - b. Economic Loss
7. Potential suggestions (at least 2) to avoid or minimize the loss.

Assignment Guideline:

3-5 pages, double space, 12 fonts, Time New Roman/Calibri.

Assignment Rubric:

- a. Selection of a natural disaster and its geographic location: 2 points
- b. Writing skill to explain the problem of that specific disaster: 3 points
- c. Explanation skill on the process of that specific hazard started to form at that location:
3 points
- d. Explanation skills on risk assessment for that specific disaster: 2 points

Exam:

There will be a total of 2 **exams** for the course. Exams will be designed to evaluate the student's understanding of the subjects covered in class and empirical and quantitative skills. Study guide will be given to help you prepare for exams.

Group Project and Group Presentation:

In order to culture and assess your teamwork ability, students will form teams of **3-6 members**, conceptualize, design, and perform a project targeting a natural disaster (energy source of natural disaster, formation mechanism, prediction and warning systems, risk assessment of that natural disaster etc.). The whole team will submit one well written and photo documented paper describing the project, the project goals, the duties of each member, the time spent (including a documented work schedule), the achievements, and the lessons learned. The team members will be required to evaluate each other's contribution to the team effort (blind evaluation) to determine 33% of each member's assignment grade. **The photo documentation** should include images showing that you participated in the project. The paper should be **a minimum of 5 written pages** excluding the title page and excluding the photo documentation page(s). Use 12 pt font, 1.5 line spacing.

Number your pages. **The paper must be sent to assignment submission folder in D2L on or before 5 pm on Dec 8. Plagiarized papers will receive a zero score! You must find team members by yourself. If your team contains less than 3 or more than 6 members, you can only receive 50% of the total points. Assignments are expected to be submitted on time.**

Group will also have to present their work in front of the class in a PowerPoint presentation. Each group member will answer at least one question. Presentation will consider 20% of your grade. So, every member should present at least 1 question.

Course Requirements and Evaluation Methods

Attendance and punctuality is required and non-negotiable.

Homework, quizzes, exams, and term paper are required.

Activities that distract surrounding people are inconsiderate and disrespectful. Activities such as texting, emailing, browsing or using cellular phones are prohibited during Lecture.

We encourage student contribution to the overall progress of the group. We encourage interactive participation. It is necessary that students have a professional and ethical behavior through the entire course. Lectures are a group activity, and so it requires social consideration and respect amongst members of the group, teachers and professors.

Penalty enforcement (I reserve the right to adjust your grade for violation of the minimum expectations).

Make-up exams will only be given if arrangements are made with the instructor before missing the scheduled exam. A documented excuse will be required.

Otherwise, **missing academic work** will be counted as zeroes in the overall grade computation
