COURSE INFORMATION

<u>Textbook</u>: Regoli, Robert M., John D. Hewitt & Matt DeLisi (2021). *Delinquency in Society*, 11th Edition Burlington, MA, Jones & Bartlett,

or the 10th Edition (2017) by Boston: McGraw Hill (publisher).

Course Description

This course begins with the history of childhood, adolescence, delinquency, and the U.S. juvenile justice system. We cover theories on the causes of delinquency for our first exam. We then examine contexts such as schools, the family, drugs and alcohol, and street gangs for our second exam. We conclude with an in-depth study of police, courts, corrections, and rule of law as applied to youth. We'll have classroom visits or zoom sessions with various professionals in the field and possibly tour juvenile courts, detention facilities, & alternative schools in the region.

Student Learning Objectives & Outcomes

- 1) To learn extensively about theories of delinquency;
- 2) To identify and evaluate the various social forces related to delinquency;
- 3) To understand how youth are viewed and processed by the justice system.

1. Exams

- There are three (3) in-class tests based on readings, lectures, and other relevant materials.
- Each test is worth 20 percent of the final grade.

Tests are a combination of multiple choice and short answer. <u>Bring the green Scantron form (882-E) and a Blue Book to test dates (items available at the bookstore)</u>. Make-up exams are allowed only for verifiable emergencies and you must contact me prior to the regularly scheduled test date to be eligible to take one. Make up exams are essay-format. 1-page study guides are provided.

The final exam (Test #3) is an in-class, non-comprehensive test based on readings, lectures, and other relevant materials presented in the final part of the term.

2. Term Paper or Presentation

Students have the option to write a term paper or make a Presentation (in class or online).

Option 1: Term paper (4-5 pages) using library & web-based research on a delinquency or juvenile justice topic. See the Term Paper handout on *D2L* for a details & guidelines.

Option 2: Individuals, pairs, or small groups may make a classroom presentation on topic(s) or theme(s) of their choice, according to what is being covered in the week they will present. For ideas, browse the entirety of the syllabus, slides, speaker videos & outside material to get ideas for topics. The quality of your presentation & brief write-up accounts for 20% of your course grade. (See the Presentations handout on D2L for details).

******Presentations begin the 3rd week of class, with a brief write-up due one week later*********.

3. **Attendance and participation** = 10 Percent of the final grade for the course.

Instructional Methods

This is a traditional, in-person lecture course. Exams are based on lecture slides and class discussion. 1-page study guides for exams are posted no less than one week before the date of the exam. All slides are made available in clearly labeled modules in D2L, organized into three major sections of the course. Material on the exam is emphasized in the slides and in lecture.

Student Responsibilities and Tips for Success in the Course

- 1. Read this syllabus with great care and pay attention to its details. Mark test dates and other important notes in your personal calendar. Revisit the syllabus periodically and ask questions if you have them.
- 2. Students should attend each class or as often as possible. We meet on Tuesdays and Thursdays.
- 3. Before each class, students should review slides and, if they have it, skim sections of the textbook chapter(s) scheduled for coverage in class per the weekly schedule (below).
- 4. To prepare for exams, students should use lecture slides to locate all items appearing on the study guide. Focus on the items appearing in red font. If you have it, use the textbook's index to locate test items and skim those sections. Also review the notes you take during class.
- 5. To do well on the Term Paper or Presentation requirement, students should select a topic as early in the term as possible and run it by the instructor for approval if the student is unsure about its suitability. Students should not wait until the end of the term to begin writing papers or propose to

make a presentation in class. Your instructor is always willing to provide feedback on early drafts of both papers and presentations. Finally, stick closely to guidelines on the Term Paper or Presentation handouts on D2L for best results, grade-wise.
