Course Information

This course explores the core concepts, challenges, and strategies involved in managing the flow of information, goods, and services across global supply chains. Students will gain expertise in utilizing qualitative and quantitative approaches to improve efficiency and tackle operational hurdles. Through this course, students will develop a profound understanding of the complexities and opportunities in global supply chain management.
