Course Description:

This course is designed to provide a comprehensive foundation in understanding the regulatory oversight of the products, services, and operational frameworks of community banks, credit unions, and farm credits. The course covers the different agencies responsible for overseeing these financial institutions and the laws, regulations, rules, and guidance used by each in their supervision and enforcement. The course will explore core deposit, lending, and general compliance regulations, while also providing insight into how these rules play into an institution's risk management program. The objective of the course is to provide a clear understanding of how these financial institutions balance their important responsibility in handling people's money with making a profit as they support the financial needs of the individuals, businesses, and agricultural segments in their communities.

Course Objectives

1. Recognize the different structures of community banks, credit unions, and farm credit institutions and how their structures impact their supervision.
2. Describe core laws, rules, regulations, and guidance and the deposit, lending, and general financial products and services for which they apply.
3. Evaluate and understand advanced oversight analysis including fair lending and fair banking philosophies.
4. Apply compliance risk management foundational knowledge and strategies in real world scenarios, understanding how these financial institutions balance operational efficiency with strong controls to quickly identify weaknesses that may lead to violations of laws, rules, regulations, and guidance..

Grading: Each student's grade will be comprised of Special Assignments (40%), quizzes (25%), exams (25%), and attendance / participation (10%).

Late Assignment Policy:

Late assignments will accrue a penalty of 10 points per day the assignment is late. An assignment is considered one day late if it is submitted past the identified due date/time. It is considered two days late if it is submitted any more than 24 hours past the identified due date/time, and so forth. This includes weekends! Once an assignment is more than 10 days late, it will become a zero and will not be accepted for credit.

If a student wants an extension for an assignment, this must be received no less than 48 hours before the assigned due date/time. Extensions are not guaranteed, and are at the discretion of the instructor. Extensions may include a late penalty.

For special assignments, you should keep the following assumptions in mind:

1. Assume you have been asked by a Senior Executive of the financial institution to prepare the assignment.
2. Spelling and grammar are very important and you should follow standard writing conventions.

Compliance Management System ("CMS") Development (20%):

The *CMS* assignment is a group project where you will work together to research the components of a CMS and how the components work together. Using what you find, your group will create a Compliance Department organizational chart with key job descriptions and will conduct a "Bank Compliance Committee Meeting" to report on the results of each part of the program. This assignment allows you to explore the expectations of regulatory agencies with fundamental requirements of a CMS. It enhances your ability to conduct a meeting, report to Executive Management, and communicate results effectively.

Risk Assessment & Bank Examination (20%)

The *Risk Assessment & Bank Examination* assignment is an individual project analyzes an agency's approach to entering into a Bank, understanding how the Bank does business, how laws are applicable, and the controls in place to minimize risk exposure where there may be violations of the applicable laws. You will experience how an examiner is responsible for making important assessments of the effectiveness of controls used to minimize compliance risks, the balance between collecting the information you need while taking care to maintain a professional and respectful relationship with the Bank. Further, critical thinking skills are developed by synthesizing insights from the class discussions and exercises into a coherent written analysis that highlights methodology, potential gaps, and control issues in assessing the effectiveness of the compliance risk management of a bank

Attendance & Participation (10%)

Students must not be passive in this course. More than before, each student should engage in classroom learning through respectfully asking questions and reflecting on the material with other class members.

Students will be evaluated based on timeliness (on time), preparedness (have researched the issue), and engagement (respectful participation in class reflections/discussion boards on subject matter and applications). Just as it will be when you begin your career, meeting deadlines is a base-level expectation and, alone, will not earn you a glowing review (e.g., a grade of 100% for the semester). **You must demonstrate additional value through your actions as part of the course.**

Netiquette

The discussion boards and other forms of online communication are created to provide an opportunity for students to actively engage in meaningful conversation on a particular topic or issue. You are encouraged to provide your honest viewpoint, but be respectful of the views of your classmates.

Do's

1. Do use correct grammar and spelling.
2. Do read the prompt, reflect on what you would like to say, and review what you've written before posting!
3. Do respect the privacy, beliefs, and opinions of your classmates.
4. Do challenge each other's ideas but not each other personally.
5. Do remember to treat others as you would want to be treated.
6. Do stick to the discussion prompt at hand when posting to a forum.
7. Do use humor and sarcasm carefully. Students cannot see your facial expressions or hear any voice inflections.

Don'ts

1. Don't type in ALL CAPS. This is regarded as shouting.
2. Don't rant or rage. This is not the place to vent your anger or start a fight.
3. Don't make inappropriate comments. Objectionable, sexist, or racist language will not be tolerated.

In the discussion forums you will post assignments and discuss your work with others in the class or in your groups. These are public forums, so whatever is posted can be seen by everyone in the course, including the instructors. If you want to send a private

message, use individual email. The Class Lounge discussion forum is a public space for conversation with your classmates on any topic or question.

General Comments:
