Course Information

Course Description

Literature of the Western World. Three semester hours. A study of selected works of fiction, poetry, and drama in the literature of Western civilization from classical times to the present.

Prerequisite: ENG 1302

This course provides students with a critical understanding of literature from the past to the present, with an emphasis on themes that reveal the human condition across time. Students will explore literature as a creative process, immersive experience, and cultural artifact, tracing major literary modes—fiction, poetry, drama, and graphic narrative—while developing a model for literary criticism.

Key Goals:

- Recognize, analyze, and respond to inherent traits of humanity across literary works.
- Engage in intellectual interaction with literature in various media forms.
- Understand literature's structural, thematic, social, political, and interpretive dimensions.

Course Objectives

- Demonstrate understanding of literary forms.
- Hone the ability to write critical essays.
- Create an original project linking course literature to contemporary life.
