Course Description: This practical, movement-based course provides tools for moving beyond “work-life balance” to creating a life of harmony that includes meaningful rest, work, and play for the body and the mind. Every meeting will include a different type of movement tailored to the group’s preferences, practical tips you can use daily, and a weekly challenge. Enjoy this time of renewing your mind and body, putting down your phone, connecting with others, and (re)introducing meaningful movement and play into your week. Wear comfortable attire in which you can move, including athletic footwear. All fitness levels welcome!

- You will be playing and working with a partner or group for many of the activities in this class. Please be courteous to your classmates by maintaining appropriate levels of personal hygiene.
