Course Description:

Welcome to ART 1303! This course is a survey of the visual arts throughout the Western and Non-western world from prehistory to the fifteenth century. Both the form and content of major works of art will be examined in relation to their social and cultural contexts.

Student Learning Outcomes:

- 1. To gain an understanding of the visual arts as an expression of human insight, imagination, and technological achievement.
- 2. To see the ways in which art reflects or communicates social, political, ideological, and religious values and constructions. 3.
- 3. To understand the development of the visual arts against the patterns and chronology of human history.
- 4. To learn themes and meanings embodied in works of art.
- 5. To recognize the interconnections between art and other expressions of human activity, such as literature, science, economics, music, and theatre.

Course Format:

This class takes place completely online! This means that other than Zoom meetings (which take place on designated Thursdays throughout the semester) we will not meet inperson throughout the semester.

The course is organized into 15 different content modules, each module corresponds to a time or region in the history of art (this also directly aligns with a chapter from our textbook). Each module contains the corresponding chapter, a Zoom link to a lecture, a discussion and a quiz that must be completed by the end of the week. Content modules are structured into one or two-week timeframes (this depends on the length of the chapter and amount of content in the module). For example, some chapters are set-up in a two-week time frame such as "Week 2&3: Prehistory and Ancient Civilizations" while others are set-up to be completed in one week. Example: "Week 12: Japan." This class is NOT self-paced, which means you MUST follow the modules, complete work each week and keep-up with the readings and ongoing deadlines.

Your grade in the course is made up of the assessments located in the content modules (discussions, quizzes and one written assignment). There is a quiz assigned for each textbook chapter/module theme which must be completed by the end of the module week.

COURSE REQUIREMENTS

Minimal Technical Skills Needed Using D2L Brightspace learning management system, Microsoft Word, Microsoft PowerPoint, or Google Slides.

Course Instruction Methods and Student Expectations: This course requires regular class attendance, completion of weekly readings/videos, and written assignments. Assignments include visual style guides and exams.

Student Responsibilities or Tips for Success in the Course

Begin each week by logging into D2L and accessing the course module we are exploring that week. If there is a discussion assigned for that week, go to the discussion topic and read through the possible prompts. You have from Monday to Thursday to make your way through chapter reading before the Zoom lecture at 9:30AM on Thursday. As you make you make your way through the reading, remember to take notes, look up definitions and consider bolded terms throughout the text. During Thursday's lecture the instructor will cover some of the material you've read about in the chapter. If the module has a discussion, this will be due on Friday before 11:59PM. Make sure to head on over to the discussion forum under the "Activities" tab to access the discussion topic for that week. Select one of the options, read through discussion instructions and make your discussion post before the deadline! If the module is structured into two weeks, the following week gives you more time to continue reading from the chapter, articles and watching videos linked to the module. Take this next week to look over materials, take notes and prepare to take the multiple-choice quiz before Friday at 11:59PM.

Announcements or email reminders will be posted on the course homepage or emailed to you when quizzes and discussion deadlines are upcoming! Make sure to check your inbox throughout the week and turn on D2L notifications for deadline reminders.

In this course you'll be reading and engaging with works of art from antiquity to modernity across regions and cultures. While your primary text in this course will be the Gardner textbook, you will also read articles and watch videos from other websites to help supplement your understanding of a particular work of art or place/time-period. You are expected to engage critically with the ideas and themes you encounter in the readings and class discussions. As you make your way through the modules and class discussions, consider how art historians make sense of works of art, how cultural context and historical background play a role in how we understand and relate to art today.

Here are some tips for actively engaging with the reading each week:

- -Pre-read and look for the organization of ideas first. You can do this by scanning the text, chapter subheadings and specific topics discussed in text boxes.
- -Underline/Highlight passages you find interesting or important.
- -Circle words you want to look up or people who seem important- look at the citations and find artists/researchers/educators researching similar topics.
- -Write thoughts or questions in the margins (unless it's a library book).
- -After reading the chapter or article, look through again to reflect on the case author made
- -Do you agree or disagree with argument or theory?
- -Write down questions you still have or thoughts that are fresh in your mind.

Please communicate with me if you have questions about the course or you are confused about assignments/expectations throughout the semester. My goal is to support you to be a thoughtful, critical student and artist. Please feel free to email me or stop by Zoom office hours. Because this class meets fully online, I will not be available to meet in-person on campus. I will do my best to address emails within 24 hours from Monday to Thursday. (See interaction with instructor statement).

Discussion Posts (each worth 7% and a total of 35% for all 5)

During five (5) different designated weeks during the semester you will complete a discussion post assigned to a content module. You have a choice between 2 Discussion prompts which are posted to each discussion topic assigned this semester. You need

only answer one discussion prompt to receive grading credit. Discussions invite you to critically engage with the chapter content and examples covered in lecture. Discussions are assigned to content modules that are to be completed in 2 weeks. All discussion posts are due on the first Friday of the weekly module. For example, for Week 2&3 Prehistory and Ancient Civilizations, your discussion post will be due at the end of week 2.

Discussion posts must be made in full sentences and be at least 100-200 words in length. Your post must answer the prompt by engaging with the material in the textbook and the module.

Your discussion post must include the following:

- Clearly addresses the prompt and demonstrates an in-depth understanding of the reading (examples provided).
- Uses professional tone, complete sentences, correct grammar and spelling.
- Cites the textbook/relevant images of works where necessary.

Tips for getting started:

- **1.** Take time to read through the textbook chapter and take notes during Zoom lecture.
- 2. Visit the Discussion forum and look up the topic for that week labeled with the title of the corresponding weekly module.
- **3.** Select the discussion prompt you wish to address. What did you find most interesting or eye-catching about the chapter/content?
- **4.** Consider your opinions, perspectives and even art historical arguments made about the topic featured in the prompt. What will you address in your response?
- **5.** Write your response and post before the deadline! Make sure to review the rubric and how you will be evaluated (see specific instructions above and on D2L).

The Contextual Analysis Paper:

It is important to understand the cultural environment in which a piece of art is produced, your thematic essay we will explore the importance of cultural context. See What is Contextual Analysis? Select one (1) work of artwork or structure that dates from Antiquity to the Gothic or a Non-Western before 1200.

- Include the image, title, date and artist if known of the artworks and/or structures you select.
 - Double-check that the dates of creation for the artworks/structures you choose date from the eras covered in class.
 - Include images at the end of the document.

- Discuss the history, politics, society, religion, education and/or economics of the time that inspired and/or influenced the artwork you selected. You may want to consider who commissioned the artwork and why.
- Identify specific elements of the selected artwork that provide visual evidence to support claims made about its historical context.
- In each paragraph, incorporate vocabulary terms in your analysis making sure to point out and explain how the artwork exhibits that characteristic. Make sure to discuss the formal properties of each artwork (line, color, pattern, media, etc.) and how those design features relate to the historical context of the artwork.

Art History Quizzes (each worth 5% and a total of 40% for 8)

You will have eight different art history quizzes in this course that will assess your knowledge and understanding of the content from textbook chapters and lectures. (all will be administered online on D2L). Quizzes are non-cumulative, meaning you will not have a final exam in this course or ever see a quiz that tests your knowledge of more than one textbook chapter at a time. Quizzes are assigned to each content module and are meant to be completed alongside the chapter readings, lecture and discussion for that week. Each quiz remains open and available for one week (from Monday-Friday) and is always due on Friday before 11:59PM. Because you have five days to complete the quiz, each student is responsible for finding designated time during the week for this assessment. NO LATE Quizzes will be accepted- please see late work policy in the syllabus.

Quizzes will remain open on D2L until the Friday they are due and will close at 11:59PM. Each quiz is made up of multiple-choice questions and has 10-15 questions total. Once you begin the quiz, you have 40-minutes to complete it. All quiz content is from the chapter/additional readings and lectures. You may use your notes from class and readings while taking the quiz.
