Course Description

A course of study initiated by the student and carried out under the supervision of a member of the faculty with appropriate expertise.

1. Demonstrate knowledge of fundamental sport management research, principles, strategies, and practices by resourcefully locating and selecting quality peer-review literature applicable to the topic under study.
2. Demonstrate understanding and competence with behavioral expectations related to ethical good practice and conduct in the workplace, or in the case of this class research, as measured by the passing scores in CITI training.

COURSE REQUIREMENTS

Students in this class will meet the instructor of this course at least once a week. The students should communicate with the instructor to find day and time for the meeting.

The syllabus/schedule are subject to change.

- Activity 1. Literature search: The student must independently or with the help of a librarian to identify an adequate amount of quality literature pertinent to their topic.
- Activity 2. Outline: The student will develop an outline for their literature review.
- Activity 3. Data Collection: The student will consult with Dr. Yu to identify a data collection method and collect relevant data.
- Activity 4. Data Analysis: The student will learn how to perform data analysis including preliminary analysis and main data analysis. In addition, the student will learn how to interpret the findings from the analysis.
- Activity 5. Draft. Student will submit the first draft of their work after at least one documented visit to the writing center.
- Activity 6. Practice presentation. Student will practice a 10 minute presentation of their literature review with the communication center and document at least one visit.
- Activity 7. Student may consider submitting the proposal to an academic conference.
