## Course Description

This course is centered on the evaluation of animals used for meat in the US., Beef, Pork, Sheep and Goats. Understanding of regional, national, and global strategies and goals for each of the meat animal industries will be covered. Broad industry goals for livestock implementation and utilization will be covered for all production systems. Intensive selection and evaluation processes will be applied to all species from both the phenotypic and genotypic perspectives within these systems. Oral reasons will be taught and applied to defend selections. Those wishing to pursue the competitive livestock judging team in future semesters should expect frequent travel and weekend involvement.

## Student Learning Outcomes

1. Identify desired phenotype of meat animal livestock species
2. Identify desired genotype of meat animal livestock species
3. Competently and succinctly defend evaluation decisions using oral reasons
4. Understand various production strategies and apply necessary selection criteria
