Purpose: This class is intended to provide students with hands-on learning experiences in field crops.

Course Text: Recommended but not required. "Principles of Field Crop Production" 4th edition. Authored by John H. Martin, Richard P. Waldren, and David L. Stamp.

Student Learning Objectives

- Recall agronomically important crops in Texas, the US, and globally
- Identify important insects, diseases, and weeds in crop production
- Understand planting, harvest, fertilizing, and spraying methods and associated equipment
- Understand role and availability of genetically modified (GMO) crops
- Interpret societal challenges and impact of field crops
- Examine field crops through the lens of experiential learning

Course Work

Quizzes/Assignments: Approximately 12 quizzes and/or assignments will be given throughout the semester. Quiz content may be over any topic covered during lab or assigned online.

Projects: 3 projects will be assigned. Project topics are: project 1- crop economic importance, project 2- role of pests in field crops, and project 3- cropping methods and equipment. Each project will be worth 100 points. Each project will have detailed instructions posted when assigned.

Essay: 1 essay will be assigned. The topic will involve crop production, GMOs, and societal impact. Instructions will be provided when assigned.

Exam: 1 exam will be given at the end of the semester. This exam will be available on D2L. Students will have unlimited time to take the exam within a one week period. The exam is open book/resource, with the exception of speaking to other students/individuals.

Lab

Quizzes/Assignments: Approximately 12 quizzes and/or assignments will be given throughout the semester. Quiz content may be over any topic covered during lab or assigned online. Quizzes may be given on D2L or in-person.

Plant Collection: Students will collect and press 10 plants and provide designated information. Plant presses will be due December 1. Plants must be properly dried for credit- molded plants will not receive credit.

Exam: One comprehensive lab practicum will be administered at the end of the semester. It will contain written and hands-on components.

Late work policy: All assignments (except your final exam) must be submitted on or before November 20 at 11:59 pm for grading consideration.
