# **Course Description**

Al 510: Seminar in Al Ethics

From the catalog: As artificial intelligence (AI) continues to transform various aspects of our lives, it becomes imperative to examine the ethical implications of its development, deployment, and impact on society. This course is a topical seminar designed to engage students in critical discussions surrounding the ethical challenges and dilemmas posed by AI technologies. Topics may vary, but may include: bias and fairness; transparency and accountability; environmental sustainability; AI and social justice, legal implications, emerging technologies, case studies, privacy issues, ethical guidelines and policy development.

# **Student Learning Outcomes**

Through a mixture of reading, writing, and discussion throughout the Fall term, students will:

- Demonstrate confidence discussing AI and ethics in a manner appropriate for your future academic or professional career;
- Identify the rhetorical use of AI in contemporary media and culture;
- Articulate the ethics surrounding major concerns/dangers of AI, especially in terms of human dignity, racism, sexism, disability, labor, and environmental impact;
- Compose arguments/persuasive media that attends to AI in accountable ways;
- Define and attempt your own goals and learning objectives related to this topic.

Throughout this course, you and I will work together to interpret, revise, and remix these learning objectives and goals. That is, our goals are flexible and will necessarily change as we move through our course. We may struggle to achieve every goal we set, and that is okay! But, as your instructor, I provide the following resources to aid us in developing our critical reading, writing, and research skills:

- Work weeks begin on Mondays. Part of your weekly readings/assignments is to view information from me (D2L Announcements) on that day.
- Research: Your research should be ongoing throughout the course. You should research in English Studies to complete activities and assignments for the course.
- Write: You will perform assignments designed to hone your understanding of researching and writing in English Studies. This includes discussion board posts, and writing assignments, among other activities.
- Discuss: Respond to your peers' writing and discussion boards as designated in the Course Schedule.
