## Course Description

This course introduces the U.S. federal government's constitutional foundations, core institutions, political behavior, and policy processes. Students engage with primary texts, explore civil liberties/rights, analyze elections, public opinion, parties, media, and interest groups, and evaluate domestic and foreign policy. Emphasis is on *applied* learning with weekly low-stakes practice, interactive "Civic Labs," and mastery checks aligned to state SLOs.

## Student Learning Outcomes

By the end of the course, students will be able to:

1. Explain the origin and development of constitutional democracy in the United States.
2. Demonstrate knowledge of the federal system.
3. Describe separation of powers and checks and balances in both theory and practice.
4. Demonstrate knowledge of the legislative, executive and judicial branches of the federal government.
5. Evaluate the role of public opinion, interest groups, and political parties in the political system.
6. Analyze the election process.
7. Describe the rights and responsibilities of citizens.
8. Analyze issues and policies in U.S. politics.

## COURSE REQUIREMENTS

### Technical Skills Needed

- Log into D2L; access modules; open HTML activities; complete quizzes.
- Upload simple text responses (when prompted) and copy/paste short reflection prompts.
- Join a Zoom session if an optional review or observation is scheduled.

### Instructional Methods

- **Pillar A — Spark (Preview & Check):** 5–10 minute micro-lesson (reading excerpt or short video) + a short "Prep Check."
- **Pillar B — Civic Lab (Interactive):** a short, branching scenario or simulation tied to the week's chapter(s), with in-line knowledge checks.

- **Pillar C — Mastery Quiz:** 10–20 questions drawn from a larger item bank; shuffle on; two attempts; highest score counts.
- **Pillar D — Application (Optional Credit):** quick, auto-graded poll/mini-case (e.g., classify a news item by institution or policy domain).

### Tips for Success in the Course

- **Pacing:** Modules open one week at a time; deadlines are posted in D2L.
- **Attempts:** Two attempts on Mastery Quizzes; keep the highest.
- **Late Work:** Civic Labs and Prep Checks remain open through Sunday 11:59 PM with a small automatic penalty applied by D2L if past the deadline.
- **Academic Integrity:** Use AI tools only when allowed in the prompt and document that use per the university's AI policy (see University Procedures).

## GRADING

### Assessments & Point Values (Auto-graded):

- **Prep Checks (15 × 5 pts) = 75 pts**
- **Civic Labs (12 × 10 pts) = 120 pts**
- **Mastery Quizzes (12 × 20 pts) = 240 pts**
- **Midterm Mastery (cumulative to Ch. 10) = 30 pts**
- **Final Mastery (cumulative to Ch. 17) = 35 pts**
- Total = 500 pts**

**Grade Scale:** A = 90–100% (451–500), B = 80–89% (401–450), C = 70–79% (351–400), D = 60–69% (301–350), F ≤ 300.

### Assessments

This course uses a **mastery-based system** designed to promote engagement and success. All assessments are completed inside D2L. Students have **two attempts** on quizzes (highest score counts) and **completion tracking** for Civic Labs.

**Mastery focus:** Each assessment is designed to provide immediate feedback and unlimited practice in D2L question libraries before graded attempts.

**Lowest scores dropped:** The two lowest Mastery Quiz scores are automatically dropped.

**Late work:** Prep Checks and Civic Labs remain open through Sunday at 11:59 PM. A small penalty (10%) is applied to Civic Labs submitted after the deadline. Mastery Quizzes close at the end of each week.

**Release conditions:** Weekly modules unlock sequentially when the prior week's Mastery Quiz is completed at 80% or higher.
