Course Description

The purpose of this class is to train you to conduct psychological research and produce a thesis. This includes all aspects of the research process: literature review, development of research materials and/or experimental procedures, research design, data analysis and interpretation, and empirical writing. The class is conducted through meetings (zoom or face-to-face) with Dr. Curt Carlson as well as group meetings with the CriMe lab's students. The goal of the class is to successfully propose, conduct, and defend your thesis project, though this entire process is likely to take more than one semester.

Course Requirements

The student will produce and defend a thesis project. If the student does not complete and defend the thesis during the semester, the instructor will assign a grade of "I" and the student will defend the thesis in a subsequent semester.
