### **Course Description and Objectives**

This course uses the basic principles of finance to develop financial models and apply them to solve common financial management problems faced by business corporations. The course uses MS Excel for building models and solving problems. Students will get opportunities to practice their modeling skills on specific finance problems. The course focuses on models for financial management problems related to financial analysis, planning and cash budgeting, risk-return trade off, asset valuation and investment decisions. The emphasis throughout will be on applications and model building rather than on theory.

The student, upon completion of this course, should be able to:

1. Build and apply models using MS Excel and use them to solve problems related to financial planning, asset valuation, investment decisions and other financial management problems.
2. Students will apply these models, where relevant, using currently available data.

### **Course Materials**

**Textbook (recommended):** Principals of Finance with Excel, 3rd Ed., by Simon Benninga and Tal Mofkadi (Oxford University Press).

**Laptop/Desktop:** Microsoft (MS) Excel.

**Note:** I will teach you how to solve problems using MS Excel. Please note that MS Excel is a Microsoft product and works best with Microsoft Windows and I will be using MS Excel in Windows. If you are using a Mac iOS, there might be compatibility issues and it is your responsibility to troubleshoot Microsoft Excel in Mac iOS.

### **Examinations**

Exams will be primarily of an objective nature, e.g., problem solving, true-false, and multiple-choice. You must not discuss exam contents with any other person. You are on your honor to help preserve the integrity of the exam. Make-up exams will ONLY be considered under extenuating circumstances. Work, personal travel, etc. are NOT extenuating circumstances. Extenuating circumstances would include school sponsored excused event (communicated by faculty advisor/coach), hospitalization, medical emergency, physical injury, or death of an immediate family member. You will be required to provide proof of the extenuating circumstance to be approved for a make-up exam.
