Course Description

Introduction to Theatre gives students an overview of what makes theatre. Students learn about not just the types of the drama that exists but the many and varied roles to be found within the theatre.

Student Learning Outcomes

1. Identify and differentiate genres and styles of theatre, placing them in their historical context
2. Discuss and analyze how theatrical performance elements come together
3. Have an understanding of how theatre is important and can be used
4. Complete a basic play analysis
5. Learn to think and write analytically about a production.
6. Gain an understanding of the global and historical influence of theatre on society.

COURSE REQUIREMENTS

Minimal Technical Skills Needed

This class will utilize a combination of papers, presentations and quizzes for assessment. Access to d2l and document writing/slide making programs is needed.

Instructional Methods

This course will be taught in person utilizing d2l

Student Responsibilities or Tips for Success in the Course

In addition to the book, there will handouts made available on d2l as needed over the course of the semester. It is expected that you read them. All assignments will be available through d2l and that is also where I expect assignments to be turned in. If you experience difficulty with that, please let me know. Any changes to the calendar will be announced in class and updated on d2l. Check d2l regularly for assignments and updates.

Exams: Two exams will be given covering the lectures and reading material. No makeup exams are given for unexcused absences. (See “Attendance” for what qualifies as an excused absence.)

The syllabus/schedule are subject to change.

Exams will include multiple choice/short answer questions, and some writing.

Quizzes: Three quizzes will be given covering the reading of the play scripts or play viewing. No makeup quizzes are given for unexcused absences.

Production Response: You will be required to attend TAMU-C Theatre productions of *The Student Showcase* and *Suzette Who Set to Sea* and write a response essay. Details about what to include in the critiques, criteria for evaluation and due dates will be discussed in class.

Section Projects: Some sections will include small projects to demonstrate the understanding of terminology and concepts. These will include both individual and group assignments.

Semester Project: Each student will complete a semester project based on their own interests in theatre or overlap with their career goals. For example, a nursing major could do a project on first aid in theatre while a communications major might do a project on the marketing of Broadway productions. These projects can be presentations, papers, playwriting, design, among other options. Students may also choose to work with one to other students on a larger project. More details will be given in class.

Participation: The participation grade consists of attending the required theatre productions during the semester, contribution to class discussions, appropriate participation in class activities, regular attendance, and adherence to class rules. Three absences are allowed before grade deductions (5 pts per absence) take place.

GRADING

Final grades in this course will be based on the following scale:

A = 90%-100%

C = 70%-79%

D = 60%-69%

F = 59% or Below

Assessments

You will be graded on the timeliness and thoroughness of your work. In group projects you will be graded on your contribution as well as the project as a whole, it is possible for people within a group to get different grades. Papers should be proofread and done in essay format. I do not require MLA formatting (but feel free to use it if you want) but your papers should be clear and well structured. Remember this is a theatre class so feel free to get creative on your projects.

A grade of “A” will not be assigned to any individual who has not completed ALL outside of class assignments. (i.e. Attendance at both departmental productions) regardless of average.
