Course Description

Research Literature and Techniques. Three semester hours. A course designed to acquaint the student with the role of research in the initiation, development, and modification of concepts and theories in physics. Articles in professional journals in the field will be assigned for review, especially in areas in which theories are in a state of flux. The student will be encouraged to devise experiments through which clarification of concepts may result.

Student Learning Outcomes (Should be measurable; observable; use action verbs)

1. Student will be able to select a relevant topic of significant interest to the community
2. Student will be able to write a concise, informative abstract
3. Student will demonstrate ability to organize the content of the paper clearly and logically

4. Student will demonstrate ability to select relevant literature from a wide variety of valid sources
5. Student will be able to synthesize information from the literature and construct a logical, well supported argument.
6. Student will use appropriate language and style for a research paper

COURSE REQUIREMENTS

Minimal Technical Skills Needed

The class involves conducting a literature review on some topic in physics or physics education; the topic should not be too broad or too narrow. The literature review paper is the sole product of the class, and your grade is based on the paper, graded according to the rubric under the course contents in D2L. The literature review paper should be 20 pages long (double spaced, including figures, tables, equations and references). We can provide some small guidance about the choice of topic, but you will be expected to come up with topic ideas yourself. We will provide a reasonable amount of help with the writing of the paper. The first thing you should do is to select your research topic. To get started, pick a particular area of research in physics or physics education, and search for literature on the topic.

Google scholar is a good place to start. If your topic is in the field of physics education, some good places to search are the ERIC database (<https://eric.ed.gov/>), Physical Review PER (<https://journals.aps.org/prper/>), the American Journal of Physics (<http://scitation.aip.org/content/aapt/journal/ajp>) and ComPADRE (<http://www.compadre.org>). For a physics topic, NASA's ADS database is the go to place to get research papers (http://adsabs.harvard.edu/abstract_service.html) (it covers all of physics, not just astrophysics). Inspire-HEP is also good, though skews toward High Energy Physics (the HEP in the title) (<https://inspirehep.net>).

If you want to run the topic by us to see if it is suitable, please email **Dr. Newton and Dr. Lock**.

You should also avoid self-plagiarism. This means that you should not reuse a paper or portion of a paper that you wrote for another class.

You may use any citation system you like as long as you are consistent. We often use the citation style of the Physical Review journals, but education journals more often use APA. Physical Review PER (<https://journals.aps.org/prper/>) is open access, so you can look at any of their papers for examples.

You can find an example of an excellent paper from a past student and the rubric under the course content in D2L.
