**Course Description**

In this course, doctoral candidates will engage in the process of developing, conducting, and defending an original research dissertation. The dissertation must address a significant problem within the candidate's area of specialization and demonstrate the ability to conduct rigorous academic research. Students will work closely with their advisory committee and adhere to institutional guidelines throughout the process, culminating in a dissertation that contributes to the existing body of knowledge. The dissertation must exhibit superior academic competence and offer a meaningful contribution to the field. This course is designed to support candidates through the stages of research, data collection, analysis, and the final defense. The syllabus and schedule are subject to change based on course progress and faculty availability.

## **Student Learning Outcomes**

By the end of this course, students will:

1. Gain a deep understanding of the dissertation process, including research design, methodology, and academic writing guidelines, through detailed engagement with course materials and faculty guidance.
2. Successfully develop and defend a dissertation proposal that clearly defines the research problem, objectives, and methodology, demonstrating the ability to conduct independent, scholarly research.
3. Navigate the Institutional Review Board (IRB) process with support from the dissertation chair, ensuring ethical and compliant research practices.
4. Conduct research, including data collection and analysis, with precision and adherence to scholarly standards, demonstrating the capacity to produce high-quality, original research.
5. Prepare for and successfully defend the final dissertation, showcasing the research findings, analysis, and contributions to the field through an in-depth oral defense before the advisory committee.

## **COURSE REQUIREMENTS**

The instructor will create an environment for learning by providing focus and guidance to the content. Assignments are designed to be learning experiences for students, and it is presumed and expected that students will actively participate in the class. As a graduate level course, the instructor expects quality work from each student supported by adequate preparation and involvement. Learning will be achieved through textbooks and other assigned readings, projects, and class interaction.

### **Minimal Technical Skills Needed**

Students should be comfortable with basic word processing, web navigation, and use of learning management systems (LMS) such as Canvas. Some assignments may require the use of presentation tools like PowerPoint or Google Slides.

### **Instructional Methods**

This course will use a combination of lectures, group discussions, case studies, interactive learning activities, and project-based assignments. Students will work collaboratively to design and critique curriculum models and engage in reflective practices about their learning.
