Course Description

Provides a study of research methodologies with appropriate practical application in relevant problem solving. Specific research types, including action research, will be emphasized. The student is required to demonstrate his or her competence in the investigation and formal reporting of a problem.

1. Understand basic concepts associated with qualitative, quantitative, and mixed methods research designs.
2. Understand how to use basic concepts by investigating and reporting of a problem.
3. Understand how to use the American Psychological Association (APA) style guidelines.

COURSE REQUIREMENTS

Minimal Technical Skills Needed

Students should be able to use the learning management system, Microsoft Word, and East Texas A&M University (ETAMU) email.

Instructional Methods

Discussion Boards:

For each discussion thread topic, students will be required to complete an “initial” post and at least two “replies” to their fellow peers’ posts. When posting the initial post and replies to peers’ posts, think about how the content adds substance or meaning to the discussion topic. In the postings, students are required to synthesize, apply, evaluate, or connect to the contents in the required and supplemental readings. Relying solely on the lectures and the textbook will be considered average work and will be graded accordingly.

For peers’ replies, it is strongly discouraged saying simple “Yes, I agree” or “I disagree”. Students need to explain why they agree or disagree and provide examples, experiences, resources, alternative perspectives, challenging views, etc., to make the dialogue richer. In addition, please remember to cite all references appropriately, quoting any use of exact wording of authors and adhering to APA and university standards. Deviation from these standards will also result in a reduced grade.

Research Design Critique Reports: One objective of this course revolves around learning about different types of research designs. In specific modules, students will complete a research design report to assess their understanding of the different designs. APA style (7th ed.) format will be required for all reports.

Final - Action Research Project:

The final will be an action research project. The specific format and content requirements for the final will be available in the course. American Psychological Association (APA) style formatting (7th ed.) will be required for the action research project. APA style (7th ed.) format will be required for this project.

Note: Turnitin.com includes an AI (artificial intelligence) checker which will be used to automatically check content and sources on the final content.
