**ECE 313 - Child Development: Early Years**

**Course Description**

This course examines theoretical and empirical research along with practical experience relating to young children. Cognitive, physical, social, and affective developmental domains are explored and implications for curriculum design and learning environments are drawn.

**Performance Assessment Description**

Students will demonstrate knowledge of foundational concepts and factors that influence development by making connections between course content, chosen context for learning (prekindergarten-3<sup>rd</sup> grade), and observations of interactive/digital media produced for young children. Students will summarize, analyze, synthesize, and evaluate an interactive media produced for young children incorporating understandings of the characteristics, progressions, variations, and interrelationships between and among development in physical, cognitive, social, language, sensory, aesthetic, and emotional domains. Additionally, students will apply knowledge of how children construct meaning and acquire knowledge and skills to plan instruction using media that is responsive to developmental characteristics and needs and motivates students to learn by employing developmentally appropriate, research-based, and evidence-based practices to create environments that are healthy, respectful, supportive, and challenging. **Note: The children's media**

- Evaluate the influence of Interactive Media on Child Development:** Students will assess interactive/digital media designed for young children, analyzing its impact on various developmental domains.
- Synthesize Child Development Theories with Real-World Observations:** Students will critically evaluate media content and its role in children's meaning-making and knowledge acquisition.
- Design Developmentally Appropriate Media-Integrated Learning Experiences:** Students will create instructional plans that incorporate interactive media, ensuring they are responsive to children's developmental needs, interests, and motivations using evidence-based practices.
- Communicate Findings Through a Professional Reaction Paper:** Students will synthesize their analysis research, and instructional applications in a reaction paper on the media's role in learning and development.
