I'm glad you're here and I'm truly excited to be your instructor.</p> <p>Please note that, in order to pass the class, you must receive an 80 or above on all quizzes and tests, as well as the culminating project (the final essay). This also means that you need to be sure to complete all exams, quizzes, tests, and essays. You have three attempts to pass your quizzes/tests, so please be careful with your opportunities. <b>It's in your best interest not to click on the quiz/test until you're prepared to actually spend time answering the questions.</b> It's pretty easy to get timed-out and then you will lose one of your three tries.</p>

If I happen to not have graded your quizzes or assignments within a few days, please don't hesitate to reach out. It really is okay. It's even okay to reach out a second time after a week or two. It's fairly easy to overlook a single submission, so I don't mind at all. With that said, please do your best to contact me about grades, rather than the East Texas A&M College of Innovation and Design office. They have enough work on their hands and, in the end, I'm the one who can most help you with regards to grades in this course.

While various types of AI are rapidly becoming useful tools, they also have immense limitations—one of those limitations being that it's painfully obvious when they've been relied upon. As such, your submissions will be weighed with several plagiarism/AI checks. AI cannot do what you're being asked to do, which is to think critically and research and compose your own work from your own mind. I'm saying this because **you cannot pass the class if AI is detected on your submissions.** You will get caught so don't go there. It isn't fair to either of us. DO NOT USE AI in any form.

Finally, please note that if you are hoping to pass this course by the acceleration deadline, then you must have everything submitted before the Friday of the fifth week of course. Moreover, keep in mind that I am just one person. Every student in this class is submitting nearly 20 assignments. If you want to ensure they get seen and are graded in an expedited manner, then please have everything in at least three

### **Course Description**

A non-credit course providing an Introduction to College Reading and Writing, ENG 100 offers an introduction to the elements of literacy necessary for college-level reading and writing. In this course, students receive substantial feedback and instructors tailored to their specific needs. This course serves as a support course for ENG 1301 and is required of those students who are not Texas Success Initiative (TSI) complete in either reading and/or writing, but this course is also available to anyone who may desire additional support for ENG 1301. This course may not be used to satisfy any degree requirement.

### **Student Learning Outcomes**

Completion of this course provides the student with the knowledge to:

1. Students will identify the elements of rhetorical analysis and understand the concept

- of reading as part of an academic conversation
2. Students will analyze and respond critically to texts written for academic audiences
  3. Students will apply academic writing conventions in their own writing to accommodate various audiences and purposes
  4. Students will learn how to conduct basic research and understand how to use it appropriately in written works

### **Textbook and Readings:**

### **Regular and Substantive Course Interaction**

As a general guide, students enrolled in a three-semester hour course should spend one hour engaged in instructional activities and two to three hours on out-of-class work per week in a traditional semester. Students are expected to double this effort of engagement given that this course is being delivered in a seven-week term. Educational activities in this course are designed to ensure regular and substantive interaction between students and faculty to ensure that students can demonstrate competency.

To be successful in this course, all content and course modules should be read and reviewed. All assignments and quizzes (both graded and not graded) should be completed. Please contact the instructor by email for any assistance.

### **Dropping the Course Due to Failure**

Students are NOT allowed to drop a course due to failure in the course. In the event a student does not make 80% or higher on a posttest or culminating project by the third attempt, the

student is not allowed to drop the course due to failure. The student is also ineligible to accelerate or re-enroll/re-take the course in the current term.

#### **Acceleration Process:**

1. Student successfully completes all required coursework in their CBE courses(s) with a grade of "A" or "B."
2. Student receives emailed verification from the assigned instructor that the course has been satisfactorily completed (Grade of A or B only).
3. Student contacts assigned advisor to provide proof of completion and discuss eligibility for acceleration into another course.

## **COURSE ASSESSMENTS**

### **Requirement for Successfully Passing Course**

Students must achieve 80% or higher for **every** posttest **and** culminating project to demonstrate mastery of all competencies and pass the course.

### **Using Remaining Attempts to Improve Grade**

Students are permitted to use remaining attempts on a posttest and/or culminating project after scoring 80% or higher to attempt to make a higher score on the assignment. Students are not permitted to exceed 3 attempts for any posttest or culminating project.

- **Must** complete all required posttests and culminating project and receive a grade on the assignments before doing additional attempts.
- The **highest** grade achieved on the posttest or culminating project will be used for the **final grade** for the posttest and culminating project.
- Please keep in mind that submitting during the final days and hours of the term means that you may not have time to resubmit or receive feedback.
- Once you have accelerated out of the course and received a completion email, you may not return to the course to resubmit work.

### **Pretest**

The purpose of the pretest is to provide students with a baseline understanding of your knowledge in the competency. Pretests are taken once and should be completed upon the first couple of days of a CBE academic term or entry into a course if a student is an accelerator. The pretest is required before you begin studying course materials. A passing score on the pretest does NOT provide permission to skip required assignments in the course. The grade on the pretest does **not** count in the final grade for this course.

### **Posttest**

At the end of a module or course is a comprehensive exam that assesses student knowledge and understanding of major concepts, theories, processes, etc., in the module or the course. A **score of 80% or higher is required** to demonstrate mastery of the competency. If a student scores less than 80% on a posttest, the student will have an opportunity to review the material and retake the posttest two additional times. Students who fail the posttest should review feedback from the instructor before reattempting the posttest on another attempt. If the posttest score is less than 80% within three attempts, students will receive a grade of “F” in the course and will be required to retake the course in the new term. All posttests in the course have a due date: **Last day of week 7, Friday by 11:59 PM CST.**

### **Culminating Project**

The final project in the course assesses your knowledge of terms and the application of concepts presented in this course. A **score of 80% or higher is required** to demonstrate mastery of each competency. If students score less than 80% on the culminating project, they will have an opportunity to review the material and resubmit the project up to two additional times. If the culminating project is less than 80% within three attempts, students will receive a grade of F in the course and will be required to retake the course in the new term. **If you want feedback**

**for revisions, submit by the end of week 6.** Culminating projects have a due date: **Last day of week 7, Friday by 11:59 PM CST.**

## **GRADING**

A score of 80% or higher on the Culminating Project and all Posttests is required to demonstrate mastery of the competencies and receive credit for the course. The following items will be used

Module 1	<u>Competency 1: Rhetorical Knowledge</u> , teaches you to read rhetorically, understanding how texts are structured to make meaning – how all the little pieces add up to the larger whole. When you engage in this kind of reading, you look for the rhetorical strategies of the writer – the patterns, structures, figures, & methods that a writer uses in order to make their point. Module 2	<u>Competency 2: Critical Reading</u> , teaches you efficient academic reading strategies. Academic reading is a specific category of reading. It’s helpful to remember that academic reading is an act of performance. Module 3	<p><b><u>Competency 3: The Writing Process</u></b>, introduces you to the importance of audience and purpose and to the writing process. Purpose is your reason for writing. Are you writing to persuade, to explain, or to issue a call to action? Perhaps you have more than one purpose. Understanding your reason for writing will help you to choose an appropriate voice. This competency also teaches you skills to develop your voice as a writer. Writing is a recursive process and involves going through these steps multiple times.
