This course introduces the concepts of surface hydrology, groundwater flow, and hydraulics of closed conduit and open channel flow. You will first learn the concepts of the fluid mechanics and Fundamental of Hydrostatics and Hydrodynamics. You will then go through hydraulics and flow in open and closed channels. Lastly, you

will be introduced to the principles of design criteria for solving problems related to culverts, sanitary sewer, and storm management systems.

Student Learning Outcomes:

Upon successful completion of this course, students will be able to:

1. Understand the concept of fluid mechanics like buoyancy, hydrostatic pressure and the forces on submerged bodies.
2. Analyze components of water resources systems, including natural and manmade waterways.
3. Analyze and design water distribution networks, and stormwater management facilities.
