Course Description(s)

MUS 152: Principal Applied. One to four semester hours. Private instruction for music majors in keyboard, voice, instruments, or composition. This course includes recitals and performance forums with teacher-directed student evaluations and instructions. May be repeated for credit.

MUS 352: Principal Applied. One to four semester hours. Private instruction for advanced music majors in keyboard, voice, instruments, or composition. This course includes recitals and performance forums with teacher directed student evaluations and instructions. All students must pass the upper division barrier examination prior to enrollment. May be repeated for credit.

MUS 552: Applied Music. (Principal applied, graduate level) One to four semester hours. Private instruction for music majors in keyboard, vocal instrumental, conducting, or composition. May be repeated for credit.

MUS 149: Music 149 is applied music at the beginner level. Intended for students majoring in subjects other than Music.

The syllabus/schedule are subject to change.

MUS 151: Minor Applied. One to four semester hours. (1, 2) Private instruction for music majors in keyboard, voice, instruments, or composition. The course includes recitals and performance forums with teacher-directed student evaluations and instructions. May be repeated for credit.

MUS 351 Minor Applied. Private instruction for advanced music majors in keyboard, voice, instruments, or composition. This course includes recitals and performance forums with teacher-directed student evaluations and instructions. All students must pass the upper division barrier examination prior to enrollment. May be repeated for credit.

MUS 551: Applied Music. (Minor applied, graduate level) One to four semester hours. Private instruction for graduate performance majors. Prerequisites: Satisfactory level assessed in the applied music performance audition.

Student Learning Outcomes

Upon completion of the curriculum:

Minors

MUS 149: Students will perform selected repertoire with technique and musicianship suitable for a non-major and appropriate to the student's musical and developmental level.

MUS 151: Students will perform selected repertoire with basic technique and musicianship suitable for a secondary performance medium.

MUS 351: Students will perform selected repertoire with basic to intermediate technique and musicianship suitable for a secondary performance medium.

MUS 551: Students will perform selected repertoire with intermediate to advanced level technique and musicianship suitable for a minor applied lesson at the graduate level.

Majors

MUS 152: In level one principal applied lessons, students will perform selected repertoire suitable to the student's musical development with intermediate technique and musicianship in preparation for the upcoming junior level proficiency exam.

MUS 352: In level three principal applied lessons, students will perform selected repertoire suitable to the student's musical development with advanced technique and musicianship in preparation for the upcoming junior and/or senior recital.

MUS 552: In level five principal applied lessons, graduate students will perform selected repertoire suitable to the student's musical development with professional level technique and musicianship in preparation for the upcoming graduate recital.

In addition, Level 1, 3, and 5 Major students will be able to do the following:

- Level 1: Students will perform *two*-octave major and minor scales in all keys, in eighth-notes at a minimum of *100 bpm* with *five* or fewer errors.
- Level 3: Students will perform *two*-octave major and minor scales in all keys, in eighth-notes at a minimum of *120 bpm* with *five* or fewer errors.
- Level 5: Students will perform *two*-octave major and minor scales in all keys, in eighth-notes at a minimum of *120 bpm* with *three* or fewer errors.
- All major students will perform selected orchestral excerpts, etudes and repertoire **with appropriate musicianship, technique and interpretation.**

The syllabus/schedule are subject to change.

- Level 5 students will perform selected pieces **from memory with appropriate technique, interpretation and style**, in preparation for the memory requirement in the Graduate Recital.
- All major students will sight-read an intermediate-level etude **with steady tempo, making fewer than 5 melodic or rhythmic errors**.

COURSE REQUIREMENTS

Instructional Methods

In-person, one-on-one applied music instruction.

Student Responsibilities or Tips for Success in the Course

Every week you will have an assignment for the next lesson, please prepare that assignment. Weekly studio class attendance is also required, and there may be assignments for studio class as well.

Interaction with Instructor Statement

The instructor expects timely communication via email, preferably within 24 hours.

Required Materials:

1. A Flute in good working condition
2. A Metronome
3. A Tuner
4. Music: Any method books and solo pieces to be announced with the instructor. **If by the third (3rd) week the student does not have necessary books/music, the lesson grade will be "0" until all materials are brought.**
5. A notebook and pencil
6. Semi-professional dress code (no workout clothes, sweatshirts, hoodies, etc.)

Objective:

Flute/piccolo lessons are designed to improve the basic fundamentals of flute/piccolo playing and to expose the student to all extremes of musicianship. Lessons will assist students in the development of:

1. tone, 2. technical & rhythmical accuracy, 3. scales, 4. etudes, 5. solo repertoire, 6. orchestral excerpts, 7. mind and body awareness (physical and mental), and 8. performance skills.

Applied lessons will occur in the Music Building every week, unless prior arrangements have been made. Please be warmed up and on time. All students enrolled in flute lessons will be **required to attend studio class once a week for one (1) hour, Mondays from 4-5pm**. Lesson times will also be scheduled by the 2nd class day. Be fully prepared for each lesson: mentally, physically, technically. Please have all necessary materials. You will be expected to learn assigned repertoire and perform a jury at the end of each semester.

GRADING

Final grades in this course will be based on the following scale:

A = 90%-100%

B = 80%-89%

C = 70%-79%

D = 60%-69%

F = 59% or Below

Assessments

Grades are based on attendance, performance, preparedness, and progress.

Students will be evaluated on a percentage basis from the following areas:

1. **Weekly private lessons** - Student will receive a grade for each lesson. This includes having all necessary materials/books/music, scales, tone production, technique, etudes, orchestral excerpts, solo repertoire, and any special assignments designated by the instructor. Lesson grades will count for **50%** of the student's final semester grade.
 - a. Students are expected to practice and prepare assignments *prior* to the next applied lesson at a high level.
 - b. Students are expected to rehearse with their pianists on their repertoire pieces *prior* to the applied lessons as assigned.
2. **Studio Class, Recital Attendance and Flute Choir Participation** will count for **15%** of the student's final semester grade. For those not able to attend weekly studio class and/or required events and recitals due to class conflicts (minors), a separate project will be assigned.
3. **Scale Jury: 10%** of the final semester grade. Students are **required** to play a scale jury *by memory* at the discretion of the instructor. See D2L for more information.
4. **Final Jury: 25%** of the final semester grade. Please read carefully as these are pre-requisites to your jury performance :
 - a. If the repertoire to be performed has piano accompaniment, the piece(s) MUST be performed with piano accompaniment. The student must secure a pianist **NO LATER THAN** Nov 1st in the Fall semester and April 1st in the Spring semester. Failure to do so will forfeit the opportunity to perform the Final Jury.
 - b. The student **MUST** have a lesson with pianist and flute instructor on jury piece(s) before finals week in order to perform the Final Jury. Students must schedule a rehearsal with pianist in advance of said lesson. Failure to do so will forfeit the opportunity to perform the Final Jury.
 - c. Students are expected to own the original score to **ALL** the material they are performing in juries and other performances and bring 2 copies for the jurors to the Final Jury, or upload 1 copy online to the provided Google Drive link. Failure to do so will forfeit the opportunity to perform the Final Jury.

The syllabus/schedule are subject to change.

- d. For MUS 149, MUS 151, MUS 351 and MUS 551 flute and piccolo students, they may have the option to arrange a separate final jury outside of Woodwind juries at the discretion of the instructor.
- e. Students must fill out the correct paperwork online prior to the jury performance time (Rep Records). Failure to do so will forfeit the opportunity to perform the Final Jury.

Note: The instructor reserves the right to make exceptions and adjustments to the course policies on a case-by-case basis, to accommodate particular circumstances.

Students are expected to demonstrate skills in pedagogy through their observation, analysis, and feedback of the performances of other students in Studio Class. This pedagogy requirement is guided by all flute instructors. Students are expected to gain skills in this area by the observation of teaching techniques in their own private lessons and through the observation of teaching techniques of other students in studio class, guest artists brought to campus, and optional conference attendance or optional observations of master teachers online.

Attendance

Students are expected to attend all lessons. Absences from lessons will be made up at the discretion of the instructor. It is the student's responsibility to notify the instructor in advance of a legitimate absence, and to secure any assignments from instructor or other students. **If you know that you must miss a lesson, please give me advanced notice (24 hours minimum via email or phone call) so that we can reschedule** (if possible—make-ups are *not* guaranteed). Lessons missed due to student vacations taken during the term will not be made up. The only excuses for missing a lesson are illness and family emergencies. If you do not give me notification in advance, you will receive a "0" for the missed lesson. After 2 absences, **your final grade may be dropped by one (1) full letter grade.**

Required Recitals:

If you are a **music major**, you are **required** to attend all flute recitals and masterclasses that are given on campus/online. This is part of your Studio Class portion of the grade (see above). There will be many other required woodwind recitals and masterclasses in the area that will be announced throughout the school year.

***Dates will be announced in weekly Studio Class as they become available.**

The applied instructor selects literature and plans lessons in a logical sequence specifically designed to prepare each student to meet the stated student learning outcomes. Thus, the literature and skills addressed in each lesson will vary according to each student's experience in performance repertoire and technical strengths and weaknesses. In practice, after assessing a student's skills and needs in the early lessons, the applied instructor often provides a more detailed overview of the semester's activities; however, this overview is specific to that student and the sequential activities are contingent upon that student's continued progress.

Bibliographical material, repertoire, library resources, applied techniques, as well as research techniques applicable to graduate study in music specific to flute/woodwind pedagogy will be surveyed and discussed. Be prepared to spend a significant amount of time doing research and review of materials outside of class.

Students are expected to demonstrate skills in pedagogy through their observation, analysis, discussion and feedback of the performances of other students. Students are expected to gain skills in this area by the observation of teaching techniques in their own private lessons and through the observation of teaching techniques of other students in studio class, guest artist classes on campus, and optional conference attendance or optional observations of master teachers online. Students will need to submit teaching videos and acquire a waiver from the student(s) in their videos.

Attendance Policy

Students are expected to attend all classes. It is the individual student's responsibility to notify the instructor of a legitimate absence in advance. It is also the individual student's responsibility to acquire any missed notes and assignments from other students and/or the instructor.
