Course Description

PSY/SPED 535 provides a focus on behavioral theory in its applied form—applied behavior analysis (ABA). Throughout this course, students will learn about the theoretical and philosophical foundations of ABA, as well as the basic concepts and

principles that guide behavior analytic research and practice. Students must be able to demonstrate mastery of the student learning outcomes.

Student Learning Outcomes

1. List, describe, and identify: (a) the goals of behavior analysis as a science and its philosophical assumptions, (b) the various branches of behaviorism, and (c) the fundamental dimensions of ABA.
2. Define, describe, and identify key concepts, vocabulary, techniques, and outcomes of the use of the basic principles of ABA.
3. Identify distinguishing elements of key concepts and principles of ABA and accurately discriminate nuanced differences among key concepts and principles.
4. List, describe, and identify the major professional associations, licensing boards, and credentialing bodies that govern and guide behavior analysts in research, practice, and professional ethics.

COURSE REQUIREMENTS

Minimal Technical Skills Needed

Students will have the ability to use word processing programs and internet-based learning management software to complete course successfully.

Instructional Methods

Each week, you will be responsible for completing an online module. In the module, you will have Readings and Assignments (may include quizzes). In addition to virtual classes and online modules, there will be a very involved applied project.

There is an applied project in this course and it accounts for much of your final grade. Therefore, it is critical that you keep up with the content at a pace that will allow you to apply it during the time sensitive applied project. You will be evaluated using a rubric that will be available for your review on D2L.

Student Responsibilities or Tips for Success in the Course

1. To succeed in this course, it is important to log in at the start of the semester and review all the modules to understand the workload. This will help you plan your schedule effectively. After familiarizing yourself with the course requirements, create a study plan that allows you to complete assignments on time. Be sure to allocate at least 90 additional minutes beyond your estimated weekly study time to ensure you are well-prepared to engage fully with the material and meet deadlines.
2. It is strongly encouraged that you take advantage of all learning opportunities throughout the course. The content is challenging, and engaging with it independently, with instructor guidance, and collaboratively with your peers will enhance your understanding. To maximize your learning, thoroughly review all provided materials, complete each module, connect with classmates studying ABA, and attend any virtual sessions offered during the semester.
3. Ideally, you should secure a placement for your applied project that aligns with your professional training goals. If you are currently working in a relevant setting, you will need site authorization from your supervisor (details to follow). If you are not in an applied setting or prefer not to complete the project in one, you may opt for a self-management project. Exceptions can be made upon discussion and approval.
4. Finally, to be successful in this course, actively utilize all available resources. Engage with peers through the discussion board, reach out to me via email with any personal questions or concerns, and contact the ETAMU librarians for assistance accessing resources. You are encouraged to schedule meetings with me outside of class as needed. Given the complexity and applied nature of this course, I am here to support you—do not hesitate to request additional guidance or discuss any challenges.

1. Professionalism: It is expected that you demonstrate professionalism. For the purposes of this course, professionalism will be exhibited by the student: (a) completing all assigned readings, (b) submitting assignments by the deadline, and (c) adhering to the university student code of conduct (e.g., plagiarism, cheating).

2. Writing Assignments: Prepare all written assignments according to the APA Publications Manual (7th ed.), as appropriate. You can access information regarding basic APA style at <http://owl.english.purdue.edu> or the Learning Center located on the main floor of the library.

a. ***ALL WRITTEN WORK WILL BE SUBMITTED TO TURNITIN TO CHECK FOR PLAGIARISM (Turnitin will provide a score of the percentage of the paper that has been directly lifted from other sources). SCORES OF 30% OR MORE WILL BE IMMEDIATELY RETURNED TO THE STUDENT FOR REVISIONS. AFTER SECOND SUBMISSION, IF THE SCORE REMAINS 30% OR MORE, THE PAPER WILL AUTOMATICALLY RECEIVE A ZERO. The BEST way to avoid any potential confusion is to get very good at stating things in multiple ways--but most importantly, in a way that is different than the original source(s). Papers in this class will likely not require direct quotes. We will discuss when it is appropriate to use direct quotes in a paper (and it isn't very often).

b. I STRONGLY encourage you take advantage of the student resources ETAMU offers you. I will reward students with bonus points if you can provide documentation that you have utilized the Writing Center to help you improve the quality of your written work. Here is a link to the Online Writing Lab:

Course assignments and projects will receive 2 points off for each day that they are late; after 3 days, it will go down by a letter grade for each day that it is late.

2. ABA Project: This assignment is designed to provide you with the opportunity to experience the seven dimensions of ABA through the applied use of some of the basic concepts and principles.

- Students will be required to complete and submit a final report
