### **Course Description**

This course covers the major aspects of modern corporate finance in the context of an economic environment. It focuses on financial decision making and an understanding of domestic and international financial markets and securities. The course begins with an overview of the domestic and international financial marketplace. Other topics covered include the time value of money, valuation of assets (debt and equity), standard theory of risk and return, capital budgeting, and other decision rules that help maximize the value of the firm.

### **Course Learning Outcomes**

At the conclusion of the course the students will be able to demonstrate proficiency in theory and the application of appropriate analytical tools to corporate decision making. They should be able to:

1. Analyze and evaluate different financial assets in domestic and international financial markets as sources of financial capital.
2. Apply present and future value concepts to special situations such as growth rates and loan amortization.
3. Evaluate strategic financial decisions in a risk/return context as it relates to today's dynamic world.
4. Demonstrate an ability to analyze and apply asset valuation techniques.
5. Students will be analytical problem solvers in business environments.

### **Exams**

There will be three exams (two midterms and Final exam) in this course with a total of 60% (30+30) of the course grade. I will drop one of the mid-terms with a lower score. Final exam is compulsory. **There will be NO automatic makeup exams.** Missing exams will receive a grade of zero. If you have a valid excuse for missing either of the tests, you must contact me with a written justification and request for makeup 10 days **beforehand**. In most cases I will require students to provide me with additional documentation to justify their inability to take the exam. Please note that a simple note indicating that you were seen at the health center the day of the exam **does not** provide sufficient documentation. Excuses will be granted if the student is unable to take the exam because of serious illness or injury, or a significant personal or professional commitment. Excuses will not be granted for trips to sporting events (unless you are representing the university) or any other reason. In all instances, the instructor reserves the right to deny any request for a makeup exam if she considers the reasons provided by the student to be insufficient.

### **Homework Assignments/Quizzes**

There will be five homework assignments, each contributing 5% towards the course grade. The assignments will be administered through D2L. Homework assignments will be a combination of Excel Assignments, Quizzes, and analysis of assigned readings.

### **Case Study**

A case study will be assigned in the middle of the semester, and students will be expected to work out the problem independently. This will constitute 5% of the course grade.

## **Discussions**

Each topic will have one graded discussion assignment in D2L. For the discussion, you are required to post one meaningful comment pertaining to that week's content, and one meaningful reply to a peer's post about each week's content. These two weekly discussion posts are worth a total of 5 points together. To get full credit, your posts must each:

- Be at least 3 sentences and 50 words in length.
- Be clearly related to the content of this week's module.
- Be accurate and/or consistent with the information presented on D2L, the textbook, and the instructor about this week's module.
- Be appropriate and respectful to classmates and the instructor.
- Be written in clear and correct language without mistakes in grammar, spelling, punctuation, or wording.
- Be original or with proper credit given to any references. The syllabus/schedule are subject to change.

Some examples of good posts are:

- Your personal and professional experience with the topic of the weekly module. If you work in the investments industry, then any non-confidential experiences from your job would make great posts to share with the class.
- Your comments, reactions, and interpretation of news articles on the weekly module topic. If references a news article then please attach a PDF of the news article, a working link to the article, and/or a formal APA-format citation to the article. Articles should be from reliable financial sources such as the Wall Street Journal, Bloomberg, or the Economist. Please take care to see that your article is accessible, to the extent that this is feasible.
- Suggestions and links to reliable outside resources on each module topic. Some good places to look for outside resources are YouTube, Yahoo! Finance, Khan Academy, and Investopedia. Tutorials and examples of financial calculations in excel can be particularly useful for this course. Be careful to evaluate the reliability of outside resources. There is a lot of useless information about finance out there on the internet. If you are unsure about a source's reliability, then try to see if their information is consistent with what is already presented for this course on D2L and in the textbook. Please also take care to see that your outside sources are accessible, to
