In particular, we will study the concepts of Exception Handling, Encapsulation and Data Hiding, Inheritance, Polymorphism, Arrays, Java Collections, and JavaFX.

This course assumes that you have little or no programming experience. It provides a solid background in good object-oriented programming techniques and introduces terminology using clear, familiar language. The programming examples are business examples; they do not assume a mathematical background beyond high-school business math.

formally submitted to the assignment folder. Email or any other formats of submission do not count and will not be graded. If you have difficulty accessing D2L temporarily, you can email me your assignment as proof of on-time submission. Neither late assignments nor labs would be allowed without the instructor's permission. The instructor should be prior notified with adequate verifiable documentation (e.g., medical letters or police reports). For the documentation, it will depend on the type of problems that you have experienced. The department and instructor reserve the right to check on the validity of the documents you submit and reject your requests/claims due to the lack of evidence. Without any valid documentary evidence, a 10% per day late penalty would be applied to submissions, including assignments and labs. Submissions will NOT be accepted or even considered more than 4 days after the due date. If this is the case, a grade of zero will be awarded for the submission or missed work.

#### B. Attendance

For the face-to-face course, students are required to attend both lectures and labs to learn cooperatively, engage actively, and communicate effectively. Attendance will be evaluated based on class participation, while lab participation will be counted as part of lab grade.

Attendance will be evaluated based on the submission of assignments and labs.
