## COURSE DESCRIPTION

How ought one to live? While we won't come up with definitive answers to this question, we will read a number of philosophers to see how they justified their different approaches to it, and we will evaluate their reasoning. Along the way we will learn about four major schools of ethics: virtue ethics, deontology, utilitarianism, and care ethics. The course is organized so that conflicting, competing, and even complementary theories will be investigated and can be discussed in interesting and civil ways. Also, this is a blended course, so some class meetings will be via Zoom or the course shell. Such meetings are not indicated on the syllabus but will be announced in advance as we go on. Assignments include four exams, one written project, and several short quizzes over the reading. The following two books are required:

## STUDENT LEARNING OUTCOMES

- Students will take exams that demonstrate an understanding of established approaches to defining and applying each of the four approaches to ethics.
- Students will complete a Transformative Project, assessing a regional service in light of two ethical approaches.
- Students will engage with multiple perspectives in exploring the human dimensions of real-world situations and problems.
- Students will be able to analyze, evaluate, or solve problems when given a set of circumstances, data, texts, or art.
- In written, oral, and/or visual communication, ETAMU students will communicate in a manner appropriate to audience and occasion, with an evident message and organizational structure.
- Students will understand and practice academic honesty.
- Students will demonstrate an understanding of societal and/or civic issues.

## ASSIGNMENTS

**Exams:** You'll take four in-class exams, each covering one of the schools of ethics we will discuss, plus other related material. These exams will solicit short answers of 3 or 4 sentences, as well as longer, more richly detailed essay responses.

**Quizzes:** You'll take six quizzes to test your comprehension of some of the reading. These timed quizzes will be given in class during the first dozen minutes or so and cannot easily be made up. Each quiz will be announced as the semester progresses, so be attentive to their deadlines.

**Transformative Project:** This assignment will require your investigation of a service program and your assessment of that program's mission in light of any or all of the four approaches to ethics. Specific assignment details are forthcoming.

**Extra Credit:** An extra credit assignment will be available near the end of the semester.

As a rule I do not accept late assignments, so please be attentive to deadlines. If you must miss an upcoming deadline, you will need to contact me to make *prior satisfactory* arrangements for fulfilling that deadline. Failure to make prior satisfactory arrangements will result in your forfeiting the right to complete that obligation. An extra credit assignment to be named later will provide an opportunity to restore points from a missed assignment, quiz or exam, simply to add points to the total grade.
