




Course Description

This course focuses on current theories of understanding student behaviors and practices of how to engage all students in learning.

Student Learning Outcomes

1. Compare and contrast various theoretical approaches to classroom management. (Program SLO #2)
2. Research and evaluate practical routines and procedures for supporting all students within a learning environment. (Program SLO #5)
3. Evaluate strategies that foster classroom community, particularly in a diverse setting. (FOCUS) (Program SLO #2)
4. Investigate views, beliefs, and experiences to determine their impact on classroom culture, community, and the learning environment. (Program SLO #3)

COURSE REQUIREMENTS

Minimal Technical Skills Needed

Students should be prepared to use the learning management system (D2L Brightspace), Microsoft Office software, presentation and graphics programs, chat programs such as Zoom and VoiceThread.

Instructional Methods

This will be a hybrid course offered bi-weekly at the Mesquite location. We will have face-to-face, synchronous Zoom sessions, with recordings of sessions offered. A complete schedule will be sent out one week before the first class day. The books will be read in book clubs-past students say this is a highlight of the course.

The weekly face-to-face offerings will be on Wednesday evenings.

Student Responsibilities or Tips for Success in the Course

1. Attend the face-to-face meetings as much as possible.
2. Read all assigned readings while reflecting on your teaching/observations.
3. Stay engaged with classmates and complete all assignments.
4. When online synchronously, be engaged & participate in learning.
5. Demonstrate a growth mindset toward new ideas on managing all parts of a classroom.
