COURSE INFORMATION

Course Description

A study of the control and prevention of common infectious and non-infectious diseases of livestock. The common parasites, their prevention, and control.

Student Learning Outcomes

1. Ability to identify signs of good and poor animal health.
2. Describe causes, methods of transmission, treatment and prevention strategies for common illnesses in various livestock species.
3. Comprehend the role and reaction of the immune system.
4. Create biosecurity plans for various operations to ensure animal and public health and safety.

COURSE REQUIREMENTS

Instructional Methods

This course will develop a student's recognition of good and poor animal health while incorporating treatment and prevention strategies for diseases common in livestock utilizing lecture formats, case studies, and discussion-based approaches.

Exam 2:

Digestive, Respiratory, and Reproductive Diseases

Exam 3:

Infectious and Zoonotic Diseases, Physical Injuries

Student Responsibilities

Two late assignments will be accepted and graded at 50%. It must be completed fully and submitted within one week of the due date.

Students are expected to attend all classes as participation points will be awarded sporadically throughout the semester in the form of pop quizzes, worksheets, and attendance.
