This course covers modern web development concepts such as client/server architecture, full-stack development, cross-platform design, and responsive interfaces. Students will explore multimedia technologies, microservices like AWS, and harness frameworks for efficient web programming. Through practical projects, students will bridge theory and practice, gaining the skills needed to excel in web development. They will create user-friendly interfaces and multimedia-rich web experiences with confidence in this dynamic field.
