Course Description

Independent Study. One to Three semester hours. Individualized instruction/research at an advanced level in a specialized content area under the direction of a faculty member. May be repeated when the topic varies. Prerequisite: Consent of a member of the Photography faculty.

This course will consist of a bi-monthly meetings to discuss the students progress. During the first week of class the student and professor will determine a bi-weekly meeting schedule. During the first 6 meetings, work in progress will be discussed, critiqued, and evaluated. During the final meeting, the final portfolio will be reviewed and discussed.
