### **Course Description**

This course provides an overview of action research, including learning about developing teacher researcher identities, blending theory with practice, and using qualitative and quantitative methodologies. Students shall produce a written action research report and presentation demonstrating their findings from a data collection process.

### **Student Learning Outcomes**

This course has been designed to provide instruction on the models of instruction and teaching and learning theories. The following are general instructional objectives for this course:

1. To examine action research and its implications for improving educational practice.

2. To understand qualitative and quantitative methodologies through teacher research experiences.
3. To explore how research inquiries within the field of curriculum and instruction may powerfully improve educational practice.

## **COURSE REQUIREMENTS**

The following requirements will constitute the grade for this course. More specific details about each assignment will be included on D2L/BrightSpace.

1. *Rear Window* observation assignment: 10%
2. Research design (with annotated bibliography and literature review sample): 10%
3. Data collection journals (observations, surveys, interviews): 30%
4. Reading and chat charts: 10% (33.33 points each for 3 charts)
5. Action research paper and E-presentation: 40% (includes first draft, peer review, and presentation)
