Course Description

Jazz lessons will allow the student to develop their understanding of jazz and jazz-adjacent music through the study of melody, harmony and rhythm with an emphasis on improvisation. This course places an emphasis on listening to primary source recordings in order to internalize style and standard jazz repertoire.

Course Content and Student Learning Objectives

- The student will learn to play melodies and improvisations with appropriate rhythmic feel.
- The student will understand the function and makeup of common jazz chords and how to improvise convincing phrases along with them.
- The student will learn jazz style and vocabulary through transcription assignments of notable jazz melodies and solos, to be performed on the student's own instrument.
- The student will develop their listening skills by studying primary source recordings including but not limited to those by great players of their own instrument.

Grading:

The student will be assigned a grade for each lesson based on their preparation of the assigned material. Assigned materials may include, but are not limited to jazz repertoire (melody and chord progression), scales, listening assignments, transcriptions, composed or arranged material. Grades will be assigned based on the following template:

- A - the student thoroughly prepared the assigned material to the best of their ability.
- B - the student prepared most of the assigned material with reasonable thoroughness.
- C - the student prepared some of the assigned material.
- D - the student did not seem to have worked on the assigned material.
- F - the student did not attend the lesson.

Attendance:

This course takes the form of weekly lessons. Students are expected to show up to each lesson on time with the lesson material prepared. When conflicts arise, lessons may be rescheduled (in-person or virtually) based on instructor availability if conflicts are communicated in advance. Any lesson not shown up for will without prior communication will result in a lesson grade of F.

Modality and Virtual Learning Expectations

This course will be provided in a face-to-face format.

The following expectations are provided should virtual synchronous class meetings be utilized for any reason:

- Students should maintain a professional appearance as would be expected in the classroom.
- Students attending synchronous classes should have their video turned on and be attentive throughout the class. Please position your camera in a well-lit professional environment.
- Virtual attendance will be taken for any class that is met virtually.
