### **Course Information**

Course Textbook – None. Reading materials will be assigned based on consultations between the student and faculty member.

### **Course Description:**

Course catalog description: A problem is chosen in the student's major field of interest with approval of the major professor. No credit is given until an acceptable thesis is completed. Prerequisite: Graduate standing.

### **Student Learning Objectives**

Through the implementation of scientific study and employing the scientific method, students will, throughout their program, gain experience and proficiency in the following areas:

1. Development of research hypothesis.
2. Composition and successful defense of research proposal.
3. Implementation of study design and collection of scientific data.
4. Analysis and synthesis of research data.
5. Composition and successful defense of a thesis.

### **Course Requirements**

Minimal Technical Skills Needed:

1. Must be able to use the learning management system (MyLeo Online).
2. Must willing to conduct the activities required of the supervising faculty.
3. Must be maintain proper attendance and working hours as designated by the supervising faculty and the study design.

4. Must have skills in writing and the analysis of statistical data.
5. Must be able to communicate via email or other necessary communication platforms.
6. Must attend all lab meetings and present data.

## **Instructional Methods**

This is a practical training course. The times and activities required to fulfill the thesis requirements will be established by the supervising individuals. On average, ten to twenty hours per week of research-related activities will be required for a productive research program. However, times will vary relative to progress and stage of research.

## **Student Responsibilities or Tips for Success in the Course**

You are responsible for ensuring that you complete all of the activities established in the research proposal and by your thesis supervisor in a timely manner. However, it is recognized that the research focus may change somewhat based on the vicissitudes inherent to biological research. In such cases the student and faculty are expected to adapt as appropriate. Students are expected to be punctual, courteous, and show ambition. Ask pertinent and relevant questions in an engaging and constructive manner. Ask to do additional work if possible and demonstrate due diligence. Must attend all lab meetings.

## **Grading and Course Content**

This is a pass/fail course that can be taken multiple times. Course content will vary with the type and nature of the thesis research and the stage of the research. This will be established by the thesis supervisor in consultation with the thesis student throughout their program. Thesis students are advised to keep a daily log of activities which will be reviewed at the end of each semester. Grading will be based on evidence of substantial progress or completion of the thesis program.

## **Grading Scheme**

I=Incomplete. Student continues to make progress toward thesis completion.  
S=Satisfactory. Student has successfully completed the requirements of the thesis.  
U=Unsatisfactory. Student has failed to complete the requirements of the thesis.
