**COURSE DESCRIPTION**

The primary focus of the course is to discover the:

- 1) history and evolution of the modern wind band
- 2) history and evolution of wind band literature
- 3) chronological highlights of repertoire from the 16<sup>th</sup> century to the present

**CLASS FORMAT**

A variety of instructional approaches will be utilized to help students develop a cognitive understanding of and appreciation for wind band repertoire. A combination of aural and written experiences will be included to aid in the learning process. Classes will include lectures, group listening exercises, group discussions, and student-led presentations.

**ASSIGNMENTS and POLICIES**

The grading scale below will be used.

**Grades will be determined as follows:**

The following formula will be used for assessing your final grade for the semester:

- Class Assignments, Journals & Daily Participation 15%
- Listening Exams 20%
- Midterm Exam 20%
- Student Presentation(s) 20%
- Final Exam 25%

**Journals**

Journaling will be a large part of this course. While listening to the compositions on the repertoire lists, students will write journal entries as a means of pursuing goals listed above in the course description.

**Listening Exams**

Listening exams will be given during the course of the semester. In addition to answering questions about class discussions and readings, students will be responsible for providing the title, composer, and other pertinent information about a prescribed number of listening excerpts.

**Midterm Exam**

The Midterm exam will focus on readings, discussions, presentations, scores and repertoire covered during the first half of the semester.

**Student Presentation**

Students will give an oral presentation on repertoire and/or topic(s) assigned. Specific research criteria will be provided separately.

**Final Exam**

The comprehensive written final exam will focus on readings, discussions, presentations, scores and repertoire found on the listening assignments spanning the entire semester.
