Course Description

In *Improvisation and Us*, faculty, staff, and administrators will explore how improvisational theatre techniques support creative thinking, clear communication, and flexible problem-solving in academic and administrative settings. Through simple, engaging exercises, participants will practice staying present, responding thoughtfully, and building ideas collaboratively. The focus is on practical skills, not performance, and all activities are designed for professional contexts.

Student Learning Outcomes

1. **Apply** core improvisational strategies (e.g., active listening, acceptance, and collaborative building) to workplace scenarios to generate responsive solutions in real time.
2. **Demonstrate** adaptive communication skills by responding constructively to unexpected challenges in structured improvisational exercises.
3. **Collaborate** effectively with peers to co-create ideas and solve problems using improvisation-based methods.

4. **Reflect** on and **articulate** how improvisational practices transfer to professional roles in teaching, administration, and staff responsibilities.
