**Catalog Description:** A course designed to acquaint elementary education majors with current health information and activities appropriate for the pre-kindergarten through fourth grade child. Principles of kinesiology, analysis of motor skills, and age appropriate interdisciplinary activities will be explored.

**Course objectives**

Upon completion of the course, the student should be able to...

1. Discuss and defend the rationale for quality health and physical education in the elementary curriculum.
2. Apply the skill theme approach to teaching elementary physical education.
3. List, define, and explain the National Standards for Physical Education.
4. Apply relevant Texas Education Knowledge and Skills (TEKS) for health and physical education.
5. Plan appropriate lessons for movement based on skill proficiency, equipment, maturation and curricular constraints.
6. Demonstrate, explain, and teach movement concepts (including space awareness, effort, and relationships) and movement skills (including selected locomotor, non-locomotor, and manipulative).
7. Plan for assessment and improvement of physical fitness and activity.
8. Plan appropriate lessons for health education based on learner age, knowledge, and developmental level.
9. Apply concepts related to classroom management and diverse learners.

**Section Quizzes and Participation**

- Each section will contain several topics. Within each topic will be assigned readings, activities, videos, etc. You may be directed to do some laboratory/research-type work and then participate in a discussion, take a quiz, and/or complete an assignment.
- ALL portions of each section MUST be completed by that section’s “end date.” You MUST do the 4 sections in order. Assignments, quizzes, etc, not submitted by the due date will receive a grade of zero. Do not wait until the last minute.
- The total point value for each section accounts for 20% of the course grade. The total point value for each section will be 100.

### **Submitting assignments**

All assignments have a submission folder. When you submit an assignment, it MUST be a WORD document (or EXCEL document if it is a spreadsheet), and it must be titled appropriately. For example, if one of the assignments is called "leadership assignment" and your last name is Collins, the name of the document you drop must be "Collins leadership."

Also, at the top of the first page of every assignment, you must include your name and the name of the assignment. If it is a spreadsheet, gridlines should be showing and a header should include your name and the name of the assignment. Print-preview your document so that if I print it, it is lined up correctly and does not have columns, rows, etc. hanging out off the edge of a sheet.

### **Feedback on assignments**

For most of your assignments, I will save your work, then use the "track changes" feature on the document itself to make corrections, write comments, etc. I will then attach the document back to you so you will have written feedback from me. In addition or instead, I may write comments in the comment box. USE this information to improve your work on future assignments.

### **Final Examination**

It is extremely important that you are LEARNING the information that is being covered in the lectures and the textbook. On the last day of the course, you will have a 24-hour period in which to take your final exam. Once you begin the exam, you will have 75 minutes to complete it. There will be a wide variety of questions which may include T/F, multiple choice, fill-the-blank, matching, short answer, essay, and application.

### **Student and Instructor Expectations**

Expectations are high for both of us. I strive to be the best teacher possible. I expect you to perform to the best of your ability. Making an "A" in this class is quite an accomplishment, and will be earned only by those who are willing to put forth the necessary effort.
