COURSE INFORMATION

Course Description

HIST 1301: A broad interdisciplinary course in the historical development of the United States and North America to 1877. Assignments will focus on reading, writing, and analysis. Prerequisites: **ENG 1301** or concurrent enrollment or **ENG 1302** or concurrent enrollment.

Student Learning Outcomes

As a Core Curriculum requirement, this class focuses on four common Student Learning Outcomes:

1. **Critical Thinking** - Students will be able to analyze, evaluate, or solve problems when given a set of circumstances, data, texts, or art.
2. **Oral/Visual Communication** - Students will communicate in a manner appropriate to audience and occasion with an evident message and organizational structure.
3. **Personal Responsibility** - Students will understand and practice academic honesty.
4. **Social Responsibility** - Students will demonstrate an understanding of societal and/or civic issues.

Student Learning Outcomes will be assessed by the Student Responsibility Quiz and a Primary Source Analysis assignment.

COURSE REQUIREMENTS

Instructional Methods and Assessment

This will be an online readings course. The readings (including two videos) will provide all the evidence you need for creating evidence-based answers to the essay questions, as well as for answering the primary source & multiple choice questions.

Assignments, Student Responsibilities, Expectations, and Tips for Success

Multiple Choice Quizzes: There are 4 multiple choice quizzes. Quiz due dates are listed on the calendar below. There are three reading quizzes that cover the text & supplemental readings and an Academic Honesty-Student Responsibility Quiz. The Responsibility quiz can be taken multiple times, but the other quizzes may only be attempted one time, and automatically end if you leave the quiz without finishing.

Primary Source Analysis Assignment: This assignment asks students to analyze information, communicate clearly and effectively, and show awareness of social and civil issues or problems. Using the selected primary source document, students should write 1-2 paragraphs that: (1) identify the author/creator and context of the document (including when and where it was created); (2) consider the purpose of the document, including the author's goals in its creation and its intended audience; and (3) evaluate the document, analyzing why this document is important to help understand the historical period or the events it describes (its significance), and how the document contributes to our historical understanding of the period (historical causes and effect). The written analysis should be presented using full and complete sentences and proper grammar and punctuation.

Essays: You must be able to write a coherent, well-structured essay that adequately addresses the question. Essays require a long-form written response, using complete sentences and appropriate grammar and punctuation. Expect to write 500 to 750 words to fully answer the prompt. You will be expected to cite any sources and quotes you use (see Student Responsibilities and Tips above), and to cite at least three reliable sources. You should only use sources assigned for this class. There are 2 Essay assignments. Each will be scored on a 20 point scale and the lower grade will be dropped.

Plagiarism:

Plagiarism is taking someone else's work and passing it off as your own words, thoughts, or ideas. This includes, but is not limited to, using direct quotes out of a book or from the internet as your own words, properly using quotation marks but noting the wrong person as the author, purchasing a paper or exam

from friends or strangers, using material from the internet verbatim as your own words, and cutting and pasting entire papers or internet pages or LLMs and passing it off as your own work. Cheating on exams and discussion posts or allowing others to copy your answers is another form of academic dishonesty. It may be acceptable to use other people's words as short quotations and ideas as long as they receive credit in citations. If you are unsure about the precise definition of plagiarism and/or think you may have committed this form of academic dishonesty, see the instructor or visit the Online Writing Lab before you turn in the assignment.

I do not usually give extra credit. Do not ask.

- 1) Use a subject line. This tells me what the topic is & prevents your message from ending up in junk.
