COURSE DESCRIPTION

This is 1-credit hour course. The course will be acted as a support to understand the fundamental chemistry topics covered by the lecture class CHEM 1312. The topics include chemical reaction rates, chemical equilibrium, acid-base chemistry, solubility, thermodynamics, electrochemistry, nuclear chemistry, organic chemistry, inorganic chemistry and biochemistry.

Student Learning Outcomes

1. Use LeChatelier's Principle to predict the effects of concentration, pressure and temperature changes on equilibrium mixtures.
2. Balance oxidation-reduction reactions.
