COURSE DESCRIPTION

General and Quantitative Chemistry Lab II. This course is part of the University Studies core courses and will meet criteria for laboratory science credits. It is the introduction to methods and techniques of chemical experimentation using quantitative and semi-quantitative procedures to exploring problems in chemistry.

Student Learning Outcomes

1. Students will be able to apply knowledge and skills to safely operate lab equipment and handle, utilize and dispose of chemicals and properly organize and return equipment at the end of experiments.
2. Students will be able to apply knowledge and skills to obtain accurate data needed to complete the experiments.
3. Students will be able to use chemical theories and principles to interpret and discuss data to draw sensible conclusions.

- Students will be able to apply the conclusions drawn from experiment6s to strengthen the concepts learned from lectures.
- Students will be able to work cooperatively with your team members to obtain data and complete lab reports.

GRADING

Final grades in this course will be based on the following scale:

The lab report with the lowest score will be dropped. The average of the grade for the rest of the eleven laboratories will constitute the laboratory grade.
