Assignments

Business Summary: Write a formal business plan that reflects the approach you actually followed in running your business. Include goals for the next 3–5 years and identify specific strategies or concepts from your major coursework or Honors courses that informed how you set those goals.

Career Prototype Interview: Identify and interview someone who owns a small business similar to yours but has been operating longer. Ask 3–5 questions focused on how they managed growth, what obstacles they faced, and what outcomes surprised them. Write a transcript of the interview and reflect on what you learned. How might their experience inform or reshape your business plan going forward?

Small Business Roadmap: Using your own business plan as a foundation, develop a roadmap that other small business owners could realistically follow. Highlight the key strategies that contributed to your business's success or growth, but frame them broadly enough to apply across different industries. Your roadmap should address core areas such as organization, marketing, and financials. Support your roadmap with 3–5 academic sources, and use your own business as the primary example throughout.

Community Engagement Project: Identify three ways your business could make a meaningful impact in your local community. Think creatively — public engagement can make you a recognizable community figure and generate lasting goodwill. Select one idea and meet with a key stakeholder who would be essential to carrying it out. For example, if you plan to offer equipment to a nonprofit, reach out to a

staff member at a local organization and explore how the partnership could work in practice. You are not required to implement the project, but reflect on the meeting: What are the pros and cons of moving forward? Who would benefit and how? Consider the broader impact your project could have and respond thoughtfully.

You may use AI resources for brainstorming, outlining, and minor editing, but all submitted work must be your original work. When using AI, provide an AI disclosure statement at the end of each assignment describing which tools were used and how.
