COURSE INFORMATION

Course Description

HIST 1301: A broad interdisciplinary course in the historical development of the United States and North America to 1877. Assignments will focus on reading, writing, and analysis. Prerequisites: **ENG 1301** or concurrent enrollment or **ENG 1302** or concurrent enrollment.

This course is designed to help students examine the developments, events, and circumstances involved in the creation of the United States of America from the Colonial Era through the Reconstruction Era. During the course, all students will be required to identify themes and ideas fundamental to U.S. History and evaluate critically explanations of historical events through brief writing assignments, class discussions, and projects. Critical thinking is essential for any understanding of American history; therefore, students will be asked to critically evaluate not just memorize the course materials. In this class, we will work together to develop the skills necessary for all students to be successful, but your participation and preparation are required.

Student Learning Outcomes

As a Core Curriculum requirement, this class focuses on four common Student Learning Outcomes:

1. **Critical Thinking** - Students will be able to analyze, evaluate, or solve problems when given a set of circumstances, data, texts, or art.
2. **Oral/Visual Communication** - Students will communicate in a manner appropriate to audience and occasion with an evident message and organizational structure.
3. **Personal Responsibility** - Students will understand and practice academic honesty.
4. **Social Responsibility** - Students will demonstrate an understanding of societal and/or civic issues.

Student Learning Outcomes will be assessed by the Student Responsibility Quiz and a Primary Source Analysis assignment.

COURSE REQUIREMENTS

Instructional Methods and Assessment

Minimal Technical Skills Needed

The minimal technical skills required for this course include using the learning management system, university email, Microsoft Word, PowerPoint and ADOBE Express.

Instructional Methods

This course will include lectures, discussions, and readings. The lectures, discussions, and readings will provide all the evidence you need for creating evidence-based answers to the essay questions on the exams and primary source assignments. The exams and primary source assignments are scheduled for in class, and you will have the entire class period to finish writing your answer.

Assignments, Student Responsibilities, Expectations, and Tips for Success

Student Responsibility Quiz (SRQ): Students will complete a Student Responsibility Quiz in D2L due in the second week of class (this will be used to assess SLO #4).

Participation/Discussions: All students must be prepared to participate in class discussions based on the assigned readings or other course contents. Students cannot earn participation credit if they do not attend class. If students have more than three unexcused absences, they will not earn all the participation. Excused absences include university athletes for scheduled events, sickness with doctor's note, or family emergency. Students are responsible for communicating with the instructor regarding their class absences. (This will be used to assess SLO #4).

Primary Source Analysis Assignments: This assignment asks students to analyze information, communicate clearly and effectively, and show awareness of social and civil issues or problems. Using the selected primary source document, students should write 1-2 paragraphs that: (1) identify the author/creator and context of the document (including when and where it was created); (2) consider the purpose of the document, including the author's goals in its creation and its intended audience; and (3) evaluate the document, analyzing why this document is important to help understand the historical period or the events it describes (its significance), and how the document contributes to our historical understanding of the period (historical causes and effect). The written analysis should be presented using full and complete sentences and proper grammar and punctuation. (The document analyses will be used to assess SLO 1-3).

Exams: These will be one essay each. You must be able to write a coherent, well-structured essay that adequately addresses the question. Essay questions will assess students' understanding of course lectures, readings, and discussions. Study questions are available in D2L. (The exams will be used to assess SLO 1-3.)

Course Specific Procedures/Policies

- **Plagiarism:** The adoption or reproduction of ideas, words, statements, images, or works of another person as one's own without proper attribution. This includes self-plagiarism, which occurs when an author submits material or research from a previous academic exercise to satisfy the requirements of another exercise and uses it without proper citation of its reuse.
- **Cheating:** Using or attempting to use unauthorized materials, information, or study aids in any academic exercise. This includes unapproved collaboration, which occurs when a student works with others on an academic exercise without the express permission of the professor. The term academic exercise includes all forms of work submitted for credit or hours.

- **Fabrication: Unauthorized falsification or invention of any information or citation in an academic exercise.**

Late Work: All written assignments are due as indicated in this syllabus. Late assignments may be accepted at the discretion of the professor and may be assessed a penalty. If you know you will be away when something is due, please notify the professor in advance or plan to turn the assignment in early. I can be very understanding and flexible with you, but only if you come to talk to me in advance. To pass this class, all assignments must be completed. Any missing assignments at the end of the course will be given a grade of zero (0).

Emailing Instructions: If you need to reach me outside of office hours, please use email. I typically respond to email within 12 to 24 hours during the week. Do not expect a response during the weekend.

When sending an email always do the following:

- 1) Use a subject line. This tells me what the topic is and prevents your message from ending up in my junk mail.
- 2) Include your class and section. I need to know exactly which of my courses you are in before I can help you.
- 3) End the email with your name, that is “sign” your message. I also need to know who you are.

Interaction with Instructor Statement

1. You are strongly encouraged to interact with me. The more you let me know what is going on with you, the better I can help you. Beyond the classroom, the best way to get in touch with me is through ETAMU email. I am also available during my office hours.
2. If you have a situation arise during the semester that will impede your ability to succeed in the class, COME TALK TO ME SOONER RATHER THAN LATER. I will be better equipped to help you in whatever ways I can the sooner you talk to me. If you wait until the very last minute, my hands will likely be tied and my options will be more limited as far as help is concerned.
